Anti-DEI

- **HB 1571/SB 420 - Official Actions of Local Governments with Respect to Diversity, Equity, and Inclusion:** Prohibits local governments from adopting or enforcing DEI-related policies, with penalties for violations and the ability for residents to file lawsuits.
- **HB 1613/SB 1694 - Prohibition of Considering Race or Ethnicity in Government Contracting:** Bans race or ethnicity considerations in government contracting, while exempting policies for small, women-owned, veteran-owned businesses, and federal compliance.
- **SB 440 - Gender Identity Employment Practices:** Prohibits mandatory use of gender pronouns inconsistent with biological sex, limits DEI-based
- **SB 1710 - Prohibitions and Limitations on Diversity, Equity, and Inclusion and Requirements for Medical Institutions of Higher Education:** Prohibits state funding for DEI initiatives, restricts DEI compliance in federal grant applications, and mandates standardized admissions testing and letter grading in medical institutions.

Elections Campaigns

- **HB 0051 - Elections:** Requires write-in candidates to pay fees, mandates election security measures, and allows manual ballot counting at precincts.
- **HB 0109 - Photography in Polling Places:** Allows photography in polling places and early voting sites under specified conditions.
- **SB 0216 - Campaign Finance:** Prohibits state agencies from using public funds to advocate for or against constitutional amendments.
- **HB 489/SB 840 - Restoration of Voting Rights Database:** Requires the creation of a statewide database to assist in determining the voting rights restoration status of certain felons. Ensures public access to the database and legal protections for those relying on it, requiring specific disclosures and imposing penalties for noncompliance.
- **HB 0831 - Elections & State-issued ID:** Requires voter registration applicants to verify citizenship and mandates specific markings on state-issued IDs for noncitizens.
- **SB 0860 - Political Ads by Government Officials:** Prohibits officials from coercing broadcasters regarding political ads and establishes penalties for violations.
- **SB 0864 - Amendment Approval Threshold:** Proposes lowering the required voter approval for constitutional amendments from 60% to 50%.
- **HB 0891 - Identification Requirements:** Expands acceptable IDs for voter registration and requires special markings for noncitizens on driver's licenses.
- **SB 0974 - Election System Testing:** Requires independent experts to observe voting machine testing and vote counting.
- **HB 1203 - Election Security & Procedures:** Enhances election system security, revises vote-by-mail procedures, and increases oversight of election crimes.
- **HB 1249 - Election Procedures:** Updates various election-related regulations, including ballot security and candidate qualifications.
- **SB 1330 - Elections:** Mandates voter registration updates, modifies third-party voter registration regulations, and increases verification measures.

- **HB 1381 - Election Integrity & Procedures:** Strengthens voter registration checks, modifies absentee ballot procedures, and enhances election security laws.
- **HB 1409/SB 1582 – Elections:** Expands voter access with same-day and automatic registration, mandates the election of the Secretary of State, introduces the Florida Voting Rights Act, and adds protections against voter suppression and intimidation.
- **SB 1414 - Elections:** Grants the Attorney General additional powers in reviewing constitutional amendments and increases election crime enforcement.
- **SB 1486 - Elections During Disasters:** Improves election procedures for counties affected by natural disasters and requires emergency preparedness plans.

Guns/Ammunition

- **HB 0053 - Sales of Ammunition:** Implements background checks for all ammunition purchases or transfers.
- **HB 0065 - Firearms Sales, Transfers, and Storage:** Requires background checks for firearm transactions, mandates safe storage, and regulates unfinished firearm frames.
- **SB 0094 - Firearms Sales to Persons Under 21:** Repeals the prohibition on selling or transferring firearms to persons under 21 years old.
- **SB 0188 - Firearms in Sensitive Locations:** Prohibits firearms in certain “sensitive locations” and establishes penalties for violations.
- **SB 0238 - Firearms Preemption:** Repeals state preemption on local firearm regulations, allowing local governments to pass stricter gun control laws.
- **SB 0252 - Weapons and Firearms:** Requires background checks for firearm sales or transfers, mandates serial numbers on firearms, and prohibits the manufacture or sale of un-serialized guns.
- **SB 0254 - Firearms:** Revises the definition of “machine gun” and classifies certain offenses related to bump-fire stocks as more severe crimes.
- **SB 0256 - Sale or Transfer of Ammunition (Jaime’s Law):** Requires background checks for ammunition sales or transfers.
- **HB 6003 - Firearm Preemption Repeal:** Repeals state preemption of firearm regulations, allowing local governments to set their own gun control laws.

Healthcare

- **HB 0021 / SB 0082 - Dental Therapy:** Authorizes Medicaid reimbursement for mobile dental services and establishes licensing requirements for dental therapists.
- **HB 0747 / SB 0780 - Doula Services in Maternal Health:** Establishes a pilot program to integrate doula services into maternal health initiatives.
- **HB 0823 / SB 0932 - Health Care Freedom Act:** Repeals restrictions on gender-affirming care and expands reproductive healthcare access.
- **SB 0870/HB 1139 - Abortion Restrictions:** Prohibits abortion after fetal viability except in specific medical circumstances.
- **HB 0975 / SB 1048 - Medicaid Dental Coverage:** Expands Medicaid coverage for adult dental services and increases reimbursement rates for providers.
- **HB 1507 - Medicaid Expansion:** Expands Medicaid eligibility for low-income adults in Florida.

Food

- **SB 0074 / HB 0119 - Universal Free School Meals:** Establishes a state-funded program to provide free breakfast and lunch to all public school students.
- **HB 0089 - Food Insecure Areas:** Allows local governments to provide support for small grocery stores in food-insecure areas.
- **SB 0980 - Hunger-Free Campus Pilot Program:** Establishes a program to address food insecurity on college campuses through state funding.

Labor/Workforce

- **HB 35/SB 510 - Heat Illness Prevention:** Requires employers of outdoor workers to implement heat illness prevention programs, provide shade, water, and annual training, with oversight by the Department of Agriculture and Consumer Services

Law Enforcement

- **HB 0113 / SB 0468 - Fleeing Law Enforcement:** Revises classification and penalties for fleeing law enforcement, including mandatory minimum sentences for certain offenses.
- **HB 0317 - Complaints Against Law Enforcement Officers:** Requires complaints against officers to be signed under oath, prevents unverified complaints from affecting careers, and penalizes false complaints.

Government

- **HB 0075 / SB 0100 - Government Flag Display:** Limits which flags can be displayed by government entities and allows military members to prevent flag desecration.
- **SB 0108 / HB 0433 - Administrative Procedures:** Revises rulemaking procedures for state agencies and regulatory bodies.
- **HB 991/SB 1242 - Community Redevelopment Agencies:** Mandates termination of all community redevelopment agencies (CRAs) by 2045, limits new projects, and restricts bond extensions.

Insurance

- **HB 1551 - Attorney Fee Awards in Insurance Actions:** Revises laws on awarding attorney fees in insurance lawsuits, specifying when prevailing parties can claim legal costs.

Education

- **HB 0261 / SB 0296 - Middle & High School Start Times:** Removes restrictions on school start times.
- **HB 0609 - Public Postsecondary Academic Freedom:** Prohibits political interference in higher education.

Housing/Landlord/Tenant

- **HB 365/SB 382 - Rent of Affordable Housing Dwelling Units:** Prevents rent increases during rental terms for affordable housing units that receive public funding, while allowing increases upon lease renewal.
- **HB 419/SB 330 - Residential Utility Disconnections:** Restricts disconnection of utility services under extreme weather conditions or emergencies, mandates customer notifications, and prohibits cost pass-through to customers.
- **HB 0615 - Electronic Notices to Tenants:** Allows landlords to send notices of eviction electronically.
- **HB 0619 / SB 1592 - Tenant Protections for Victims of Violence:** Prohibits eviction of tenants who are victims of domestic violence.
- **HB 873/SB 1500 - Vacating Premises After Rental Agreement Termination:** Requires landlords to give pregnant tenants or those with children under 18 at least 3 months to vacate after rental termination.
- **HB 1471/SB 1592 - Housing Reform:** Expands rental protections, tenants rights, and establishes affordable housing programs.

Other

- **HB 0387 / SB 0476 - Discrimination Based on Hairstyle (CROWN Act):** Bans discrimination based on natural hair texture or styles.
