In addition to these inserts, we have a few other ways available for your community to engage with *Public Witness in the Pews 2020*:

- **During your announcement time each week**, mention the insert, the February 11th Climate Day of Action and the February 14 Youth Homelessness Advocacy Day, both at the State Capitol.
- **Place a paragraph in your worship bulletin** weekly through the end of session. Carve out a spot in every bulletin where people know they can find an EMO advocacy update and advocacy-related events.
- **Attend** the February 11th Climate Day of Action and the February 14 Youth Homelessness Advocacy Day!
- **Host a "Public Witness in the Pulpit" Sabbath with worship, preaching and teaching** focused around faithful public witness. EMO can provide guest speakers and has worship, education, and action resources for this and other special Sabbaths on our website.
- **Tell other clergy** about EMO's Public Witness in the Pews 2020, and recruit participants from clergy groups you attend.
- **Include information** in your denominational newsletters.
