Climate Justice

ISSUE BACKGROUND

Climate justice is a movement to acknowledge that one of the most pressing issues facing humanity today is the climate crisis. Global temperatures are rising, causing a cascade of impacts on ecosystems.

But climate change isn't just a global concern. Our region has experienced unprecedented patterns of consecutive warm summers in the past decade; hot, dry summers exacerbate forest fires, dangerous storms, heat-related deaths and drought. Disasters impact low-income families most directly.

This crisis has ramifications across borders; it is a justice issue as much as an environmental one, because the people facing the burden of coping with it are those who are both least responsible and least equipped to face its effects. The climate crisis exposes our world's existing social injustices in need of transformation.

WHY IT MATTERS to people of faith

Religious traditions worldwide encourage a loving relationship with the Earth. In his groundbreaking encyclical, *Laudato Si*, Pope Francis reminded followers of the centrality of creation care to the life of faith: "Living our vocation to be protectors of God's handiwork is essential to a life of virtue; it is not an optional or a secondary aspect of our Christian experience."

CREATION CARE for Oregon now

The signature climate justice bill coming before the Oregon Legislature this Session is the Clean Energy Jobs Bill. The core principle of the bill is to cap the amount of climate pollution from the largest emitters, charge emitters for pollution over the set limits, and invest the funds in jobs that are building our sustainable, clean energy future economy, like transportation upgrades, energy efficiency in homes and affordable solar power. Over 48,000 Oregonians already work in clean energy jobs, and this bill will boost investment in these jobs for people across skill sets and professional training. Oregon's governor and leaders in both chambers of the State Legislature have supported this effort, so we are hopeful we can see this goal reached.

MORAL URGENCY

ADVOCACY TIP

CLIMATE AS COMMON GOOD

Pope Francis offers a challenge to not only religious followers, but also civic leaders, to work together for policy changes that address the climate crisis and achieve what no one can do alone:

"There is an urgent need to develop policies so that, in the next few years, the emission of carbon dioxide and other highly polluting gases can be drastically reduced, for example, substituting for fossil fuels and developing sources of renewable energy... International negotiations cannot make significant progress due to positions taken by countries which place their national interests above the global common good. Those who will have to suffer the consequences of what we are trying to hide will not forget this failure of conscience and responsibility."

Religious communities have a role to play. Scientists can explain natural phenomena or develop technological advances, but it is people of faith whose expertise is in identifying a moral vision for our future.
