

## KING COUNTY YOUTH BILL OF RIGHTS GIFT CARD DRAWING FOR TEN \$100.00 GIFT CARDS.

### OFFICIAL RULES

**Important:** Please read these rules if you plan to submit an entry for the King County Youth Bill of Rights.

By submitting a form for the King County Youth Bill of Rights, you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements below.

#### ***SUBMISSION VOID WHERE PROHIBITED.***

1. **Eligibility.** You are eligible to be entered into the drawing if you live in King County, are between 5-24 years old and you have filled out a YBOR survey include your email address (no typos), your age, your zip code, and at least one (1) bill of right declared—and not something like “paint my cats tail pink”, something legit. You can do this online or at a “right station”.

The wonderful people at King County and DCHS and their kids are not eligible to win these gift cards. Sorry friends!

2. If your late, it's not King County's fault or their employee's fault or their community partners' fault. We are all going to do our best to make sure that you are entered into the drawing.
3. **Submission period:** You can submit from now until November 1, 2021 at 11:59 p.m.
4. **How to enter.** You can enter by filling out a form at a right station or by visiting <https://publicinput.com/KCYBOR>. You also can scan the cool QR code on our online and other ads. Fill out the stuff mentioned above in #1 (eligibility).
5. **Selection and notification of awards.** Ten youth will be picked via a random drawing on December 1, 2021. (We might do this live on Zoom.) If your name is picked, we will contact you. If we don't hear back from you by the end of the month, we will give it someone else. Sorry.
6. **Prizes.** Ten (10) \$100 VISA gift cards. Each prize is valued at \$100 dollars.
7. **Odds.** Odds increase the more time you enter, but don't go crazy and use a bot. We will notice that. Also, you have until December 15, 2021 to claim your prize. You cannot give your prize to someone else (except your parents if you are really young.) You cannot receive cash or something else worth \$100.00. It will be a gift card.
8. **General release.** If you enter a submission, you are agreeing to not hold DCHS or King County or any of our friends responsible if you don't win or if you lose your prize

or if you don't claim your prize. If you give us the wrong email, that isn't on us. If your dog eats your gift card, that isn't on us. We will do our best to respect you and not say and/or do anything to embarrass you. Please do the same for us. Thank you.

12. **Affidavit & Release.** So, just in case someone tries to trick us (which you would never do) we might have to ask folks to verify their age and eligibility. Just in case...
