

KING COUNTY YOUTH BILL OF RIGHTS GIFT CARD DRAWING FOR TEN \$100.00 GIFT CARDS.

OFFICIAL RULES

Important: Please read these rules if you plan to submit an entry for the King County Youth Bill of Rights.

By submitting a form for the King County Youth Bill of Rights, you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements below.

*SUBMISSION VOID WHERE PROHIBITED.*

1. Eligibility. SUBMISSION WILL INCREASE ODDS OF RECEIVING AWARD; VOID WHERE PROHIBITED. THIS SUBMISSION IS OPEN ONLY TO RESIDENTS OF KING COUNTY, WASHINGTON, U.S.A. WHO ARE BETWEEN FIVE (5) YEARS OF AGE AND TWENTY-FOUR (24) YEARS OF AGE. IF YOU ARE NOT A RESIDENT OF KING COUNTY AND AT LEAST FIVE (5) YEARS OF AGE, AND UNDER TWENTY-FOUR (24) YEARS OF AGE, THEN YOU ARE NOT ELIGIBLE TO PARTICIPATE IN THE RANDOM GIFT CARD DRAWING/GIVE-A-WAY, AND DCHS COMPANY (AS A DEPARTMENT OF KING COUNTY FOR THIS GIVE AWAY WILL BE HELD) RESERVES THE RIGHT NOT TO AWARD PRIZES TO YOU. To be eligible to receive a prize, entries must complete and submit the King County Youth Bill of Rights survey form either online or at a "right station". Directors, officers and employees of King County Department of Community and Human Services and any of their professional advisors and immediate families of each are not eligible to receive any prizes. All applicable federal, state and local laws and regulations apply.
2. Disclaimer. King County DCHS, all participating sponsors and any of their respective affiliates, directors, officers, professional advisors, employees and agencies will not be responsible for: (a) any late, lost, misrouted, garbled or distorted or damaged transmissions or entries; (b) any YBOR submission disruptions, injuries, losses or damages caused by events beyond the control of Sponsor; or (c) any printing or typographical errors in any materials associated with the Submission.
3. Submission Period. The Submission starts at 9:30 am (all times Pacific Time) on September 7, 2021 and ends at 11:59 pm PST on November 1, 2021 (the "*Submission*" or "*Declare your Rights Period* "). All entries must be received during the Submission Period and must meet all other requirements in these Official Rules to be eligible to receive a prize. Sponsor's computer is the official time-keeping device for the Submission.
4. How to Enter. To enter, during the Submission Period, (1) Visit <https://publicinput.com/KCYBOR> (2) Complete and submit a form (declare a right) entry form (providing your e-mail address, zip code, age, and at least one (1) right declared on the submission form) and agree to the Official Rules. Entries will be accepted until 11:59 pm PST on 11/1/2021. Submissions received from any entrant (using multiple or different applicable accounts) in excess of four (4) unique forms will be void. Limit four

entry forms per person during the Submission Period. By entering the submission, you consent to be placed on an e-mail mailing list for YBOR contact purposes. However, you may opt out of receiving e-mails from Sponsor/DCHS for the purposes of informing you that you have won and/or to provide updates on the King County Youth Bill of Rights project and final outcome.

5. Selection and Notification of Awards. Ten (10) awardees will be chosen by random from all eligible entries, to be held at a DCHS home office location and video recorded. The awardee will be notified by e-mail by December 1, 2021. To claim their prize, the awardees should follow the instructions contained in his/her/their notification.
6. Prizes. Ten (10) \$100 VISA gift cards. Each prize is valued at \$100 dollars.
7. Odds; Taxes, Etc. Odds of being awarded a prize depend on the number and quality of eligible entries received. ALL FEDERAL, STATE AND LOCAL TAXES ASSOCIATED WITH THE RECEIPT OR USE OF ANY PRIZES ARE THE SOLE RESPONSIBILITY OF THE AWARDEE. All prizes will be awarded. If a prize is returned as undeliverable or otherwise not claimed within fifteen (15) days after delivery of notification, the prize will be forfeited and awarded to the next random awardee of eligible entries. Prizes are not transferable. No substitutions or exchanges (including for cash) of any prizes will be permitted, except that DCHS reserves the right to substitute a prize of comparable or greater value for any prize. Any and all prizes awarded are "AS IS" and WITHOUT WARRANTY OF ANY KIND, express or implied (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose).
8. General Release. By entering the Submission, you release Sponsor (DCHS), participating sponsors, and any of their respective parent companies, subsidiaries, affiliates, directors, officers, employees, and agencies (collectively, the "Released Parties") from any liability whatsoever and waive any and all causes of action, related to any claims, costs, injuries, losses, or damages of any kind arising out of or in connection with the Submission or delivery, misdelivery, acceptance, possession, use of or inability to use any prize (including, without limitation, claims, costs, injuries, losses and damages related to personal injuries, death, damage to or destruction of property, rights of publicity or privacy, defamation or portrayal in a false light, whether intentional or unintentional), whether under a theory of contract, tort (including negligence), warranty or other theory.
9. LIMITATION OF LIABILITY. THE RELEASED PARTIES SHALL HAVE NO LIABILITY FOR ANY LOST PROFITS OR OTHER CONSEQUENTIAL, SPECIAL, PUNITIVE, INDIRECT, OR INCIDENTAL DAMAGES, ARISING FROM OR RELATED TO YOUR PARTICIPATION IN THE SUBMISSION OR USE OR INABILITY TO USE ANY EQUIPMENT PROVIDED FOR USE IN THE SUBMISSION OR ANY PRIZE, EVEN IF A RELEASED PARTY HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. IN NO EVENT SHALL THE AGGREGATE LIABILITY OF THE RELEASED PARTIES ARISING OUT OF OR RELATING TO YOUR PARTICIPATION IN THE SUBMISSION OR USE OF OR INABILITY TO USE ANY EQUIPMENT PROVIDED FOR USE IN THE SUBMISSION OR ANY PRIZE EXCEED THE GREATER OF ONE HUNDRED DOLLARS (\$100). THE FOREGOING DISCLAIMER OF CERTAIN DAMAGES AND LIMITATION OF LIABILITY WILL APPLY TO THE MAXIMUM EXTENT

PERMITTED BY APPLICABLE LAW. THE LAWS OF SOME STATES OR JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION OF CERTAIN DAMAGES, SO SOME OR ALL OF THE EXCLUSIONS AND LIMITATIONS SET FORTH ABOVE MAY NOT APPLY TO YOU. NOTWITHSTANDING ANYTHING TO THE CONTRARY IN THESE TERMS, NOTHING IN THESE TERMS EXCLUDES OR LIMITS THE RELEASED PARTIES' LIABILITY FOR DEATH OR PERSONAL INJURY CAUSED BY ANY OF THE RELEASED PARTIES' NEGLIGENCE OR FOR FRAUD.

10. Use of Awardee's Name, Likeness, etc. Except where prohibited by law, entry into the Submission constitutes permission to use awardees' name and/or prize information. As a condition of being awarded any prize, except where prohibited by law, awardees may (in Sponsor's sole discretion) be required to execute a written consent confirming Sponsor's right to the use of the awardees' name, likeness (visual, aural, or otherwise) and/or prize information, without limitation, for promotional purposes without further permission or compensation.
11. Privacy. Except where unlawful, all actions by King County are subject to public disclosure.
12. Affidavit & Release. As a condition of being awarded any prize, awardees may be required to execute and deliver to Sponsor a signed affidavit of eligibility and acceptance of these Official Rules and release of liability, and any other legal, regulatory, or tax-related documents required by Sponsor in its sole discretion.
13. Awardees List; Rules Request. For a copy of the awardees list, please contact the King County Department of Community and Human Services communications division.
14. Miscellaneous. The Submission and these Official Rules will be governed, construed, and interpreted under the laws of the State of Washington. Entrants agree to be bound by these Official Rules and by the decisions of Sponsor, which are final and binding in all respects. Sponsor reserves the right to change these Official Rules at any time, in its sole discretion, and to suspend or cancel the Submission or any entrant's participation in the Submission should viruses, bugs, unauthorized human intervention or other causes beyond Sponsor's control affect the administration, security or proper play of the Submission or Sponsor otherwise becomes (as determined in its sole discretion) incapable of running the Submission as planned. Entrants who violate these Official Rules; tamper with the operation of the Submission; violate any law, rule or regulation in connection with participation in the Submission; or engage in any conduct that is detrimental or unfair to Sponsor, the Submission or any other entrant (in each case as determined in Sponsor's sole discretion), are subject to disqualification from entry into the Submission. Sponsor reserves the right to lock out persons whose eligibility is in question or who have been disqualified or are otherwise ineligible to enter the Submission.
