### SCAC Artist Rules

- Artists must be a current member of the Shasta County Arts Council, (SCAC).
- Permits must be prominently posted during selling hours.
- Artists must accept stall space assigned by event manager.
- Artists shall only sell hand-crafted artwork that are listed above and thereby have been approved for sale.
- Artists must be completely set-up by 2:00 pm and must remain open until 7pm.
- Artists must disassemble booths and depart the event site no later than one hour after the event closes.
- Artists shall maintain stall spaces in a clean and sanitary condition.
- No refunds on booths.
- Artists are responsible for Terms and Conditions of Sales Tax, delivery, and insurance. \*\*If you do not show up at the designated time or leave early you will forfeit your booth fee and will not be invited to future events.

## INFORMATION AND RULES SHEET FOR SCAC ARTISTS

- \* All work must be designed and/or hand-crafted and sold by the Artist.
- \* A review committee will jury art/craft work.
- \* Artists may sell only those items approved by the committee.
- \* There will be no agent or third party selling. You must be a current member of the SCAC. \*  
We reserve the right to deny participation to anyone not meeting SCAC standards. Persons selling items not approved by the review committee will be asked to remove the items and will not be invited back.

### REGISTRATION:

- \* Each application will be judged individually. We must have three color photos of the work you will be selling. It is essential that your photos accurately and clearly show your work. No Polaroid's. If an artist is not selected for participation, pictures of the art will be returned.
- \* ***Applications are due by September 24, 2021.***
