# PGCEA MEMBERS CALL FOR CHANGES IN THE 3 GRADE PER WEEK POLICY

On Wednesday, September 12th the PGCEA Board of Directors voted to send a letter to Dr. Goldson regarding the change in policy, that requires a minimum of three grades per week. The letter states that:

- 1. The new policy is an overreaction to the grade changing scandal of last school year. Three (3) grades per week, per student, will not prove to the community that the school system is transparent and accountable.
- 2. The new policy places an undue burden on teachers. Instead of planning lessons, they will be spending their time grading and putting the grades into SchoolMax.
- 3. Elementary grades will be counting a 90 minute block as two (2) classes per week, because a usual class is 45 minutes.
- 4. Teachers are more and more burdened with paperwork, testing, and now extra grades.
- 5. We need to have time to teach without worrying about giving a grade for each class.
- 6. This has historically resulted in lower grades for our low performing students as they tend to receive more grades of zeros for not turning in these assignments. It is extremely difficult to offset those zeros with higher grades. For example, every zero a student receives requires two (2) scores of 100 to bring their grade up to a D. Students give up much more quickly under these grading policies, perpetuating the cycle of academic failure.


