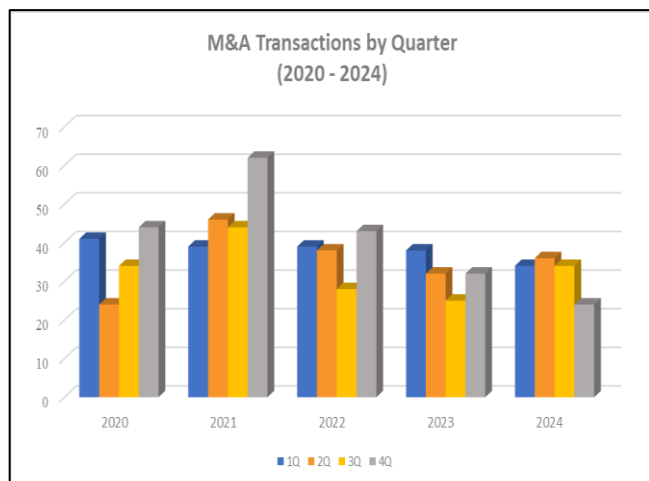

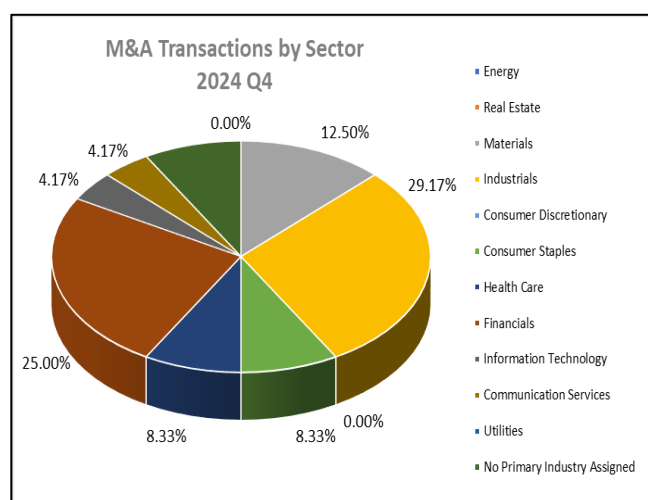
2024: Where Will We Go From Here?



The fourth quarter of 2024 recorded just 24 closed transactions, marking the lowest fourth quarter volume observed in recent history. Typically marked by a flurry of year-end transaction activity, the fourth quarter of 2024 was materially slower with deal flow decreasing both quarter-over-quarter and year-over-year. After a strong year-to-date, the lackluster Q4 transaction volume in the Pittsburgh region appears disappointing. However, on a positive note, recorded deal volume for the year totaled 128 closed transactions, just slightly eking out the total of 127 deals tracked in 2023 and marking the first year-over-year increase (albeit slight) in annual transaction volume since 2021. As we look forward to 2025, dealmakers across the region remain hungry to transact around high-quality assets that meet their parameters.

On the S&P Capital IQ platform, transaction values are more readily discernable for deals considered “private placements” versus “mergers and acquisitions.” Of the 21 private placement transactions identified in the fourth quarter of 2024, 18 transactions had enterprise values associated with them (after accounting for one low-end outlier). Looking at the transaction data, the sample included a minimum value of \$50,000, a median value of \$2,400,000, a mean value of \$7,230,000, and a maximum value of \$32,300,000. Notably, the largest private placement in Q4 took place in the Health Care sector in October, with PeopleOne Health, Inc. receiving \$32.3M in Series B funding from GV Management Company, LLC (see transaction details on page 4 of this report).

While activity across the board trended lower, the Industrials sector remains an M&A driver in the region, accounting for 7 of the 24 (29.2%) recorded M&A transactions during the fourth quarter of 2024. The Financials sector also picked up steam in Q4 with 6 recorded transactions. The Energy, Real Estate, Consumer Discretionary, and Utilities sectors each recorded zero transactions in Q4. The sectors including Materials, Consumer Staples, Health Care, Information Technology, Communication Services, and those with no industry assigned combine to make up the remaining 11 M&A deals.

Regionally, the Pittsburgh Area accounted for 11 of 24 (45.8%) recorded transactions in the fourth quarter of 2024.
