2021 JCTA/KEA General Election Candidate Resumes

JCTA OFFICERS

PRESIDENT

McKim, Brent–VanHoose—Thank you for trusting me to lead the educators of Jefferson County as JCTA president. I believe leadership means transparently empowering and engaging our members and community partners. Together, under my leadership, we stood up to Frankfort politicians and defeated efforts to undermine our retirement security, fund charter schools, and implement vouchers, championed racial justice, expanded restorative practices, implemented a JCPS racial equity policy, and implemented a national award-winning JCTA diversity training cadre, dramatically reduced the number of district-required assessments, defeated an attempted state takeover of JCPS, won a Circuit Court victory blocking a TEA Party effort to recall \$54,000,000 in new revenue for JCPS, were the only urban teacher union in the nation to navigate the transition to an all-red legislature without losing any bargaining rights, contract provisions, or other member or union rights, increased membership by over 1,000 and, partnered with community allies to advance student success. As never before, public education is under attack. At this critical time, JCTA needs a proven leader with the experience, relationships, and expertise to defend our members, advocate for safe, equitable schools, and stand up for our retirement security. I am that leader and I ask for your vote.

Tyson, RaShauna – Frost Middle—My name is RaShauna Tyson. This is my 13th year as a math teacher and seventh as a PR rep. I just recently completed my Master's in School Administration. Teaching is my second career, but the most rewarding. Prior to teaching, I held leadership roles with H&R Block and JPMorgan Chase Bank; therefore, leadership does not scare me. What does scare me is the turn our union continues to take with the lack of transparency or democracy. My goals are transparency, membership engagement, and a more direct voice for the membership. Our webpage should highlight our committees, so that members can be educated and even join, if they're so moved. That's what we need to increase member engagement. JCTA should stop being stagnant with the same strategies that lead to the same outcomes. Just as the world is evolving, so should our union.
