TRINITY HIGH SCHOOL SCRIP SCHOLARSHIP AGREEMENT

Trinity High School sponsors a Scrip Scholarship Program which provides the opportunity to purchase gift cards and gift certificates that generate rebates from participating retailers. The rebates obtained through the purchase of these gift cards/certificates will be used for tuition assistance and will be distributed by the Scrip Scholarship Program to qualifying families.

As a participant in the Scrip Scholarship Program, you agree and acknowledge the following:

You agree to purchase gift cards/certificates, an average of \$200 per month/\$2400 per year, during the course of the year, which for purposes of the Scrip Scholarship Program, runs from January 1st through December 31st.

You are the owner of the gift cards/certificates purchased, and, as such, the cards/certificates should be treated as cash, and are non-refundable and non-returnable.

Neither Trinity High School nor the Scrip Scholarship Program is responsible for any lost, stolen, or damaged gift cards/certificates.

You are responsible to be aware of any expiration or restrictions placed on the gift cards/certificates by the retailers.

The tuition assistance distribution pool will occur once during the course of the year, will be based on purchases of gift cards/certificates made between January 1st and December 31st, and will be applied to the March 15th tuition payment.

Failure to purchase gift cards on a periodic basis during the course of the year will result in disqualification from consideration in the tuition assistance distribution pool.

If you no longer pay tuition or no longer have a tuition account for a student at Trinity High school, you may purchase gift cards/certificates on behalf of a family with a student at Trinity High School and so designate that family as a participant under this agreement or donate back to the school.

If at the time of the tuition assistance distribution pool: your tuition is paid in full, and you no longer have a student at Trinity High school and you do not designate another family with a student at Trinity High School, you agree that any tuition assistance distribution that could be made on your behalf is hereby donated back to the school.

This agreement continues unless replaced by another and can be terminated upon thirty (30) days advanced written notice either by participant or as directed by the individual responsible for operating the scrip program at Trinity High School.
