

## Civil Rights Journey

**What is it?** This trip is planned and led by Etgar 36, which organizes educational trips for people of all generations. We will travel to Atlanta and from there by bus to important sites in the history of the fight for civil rights in America in the 20th century. By the end of our trip, we will have a deeper understanding of why Jews, as a people who have known oppression, must care and act when others are oppressed. Sample itinerary includes:

- Travel to Montgomery, Alabama to learn about Rosa Parks and the Montgomery Bus Boycott as well visiting the Equal Justice Legacy Museum and Equal Justice Memorial to Peace and Justice,
- A visit to the Edmund Pettus Bridge in Selma, Alabama, where we will meet with a participant from the historic march across this bridge, and
- The opportunity to experience worship services on Shabbat with Temple Beth Or, Montgomery, and Sunday morning services at Ebenezer Baptist Church (historic church of Dr. Martin Luther King Jr.), Atlanta, Georgia.

**When is it?** Thursday, April 13, 2023 to Sunday, April 16, 2023.

*Please note: Each participant is responsible for making their own flight arrangements. We will be meeting the staff from Etgar 36 at 9:00 pm, April 13, at the Hartsfield-Jackson Atlanta International Airport to travel to the hotel together. Return flights to New York should be made for later than 3:30 pm.*

**Who is it for?** Shir Ami Members and guests.

**What does it cost?** The cost of the trip covers hotels, ground transportation upon arrival in Atlanta to all locations, and admission to the various sites. It also includes most meals (entree and soft drink or juice). Note: Food while enroute to and from Atlanta is not included. Some spending money is recommended. The cost of the trip depends on the number of participants and, while we are awaiting final costs from our trip provider, we estimate the following:

- Maximum cost per person based on 2 people in a room: \$1200 per person.
  - \$285 single room supplement
