Dear Governor Wolf,

As you have acknowledged, physicians and other health care providers are putting themselves at risk as they continue to serve Pennsylvania's medical needs. Outpatient services and ambulatory surgical care centers want to join in the efforts and open their doors. These providers will assist in the efforts to prevent and treat acute illnesses, chronic conditions, and non-emergent needs. A complete and successful health system demands both components of that system, inpatient and outpatient, to provide equally safe and efficient care.

Physician offices and outpatient facilities are critical components of the re-opening effort. Their essential services of cancer screenings, administering non-emergent and preventative care for patients, and tending to their mental health, help keep individuals out of the hospitals and Crisis Response Centers. Although, and similar to the rest of the medical community, they must protect their patients and healthcare workers in the same manner as hospitals and health systems.

We applaud your efforts to support health care facilities and front-line workers. However, health care providers who deliver outpatient care and would like to reopen are not being helped in their effort to safely reopen. Discussions with multiple medical and surgical specialties, have repeatedly and emphatically emphasized that practitioners cannot reopen their outpatient offices and facilities due to shortages of resources for rapid testing. Effective and efficient outpatient care is crucial. Outpatient offices and facilities, nonetheless, like inpatient facilities, need access to those necessary resources.

Without help for private practitioners, outpatient facilities and ambulatory surgical care facilities, patients will have no choice but to go to hospitals for their care. At a time when Pennsylvania is near flattening the curve of COVID-19 cases, emergency departments and health systems do not need additional patients. Furthermore, these health-compromised patients do not, and should not, endure potential exposure risks with COVID-19 patients.

Therefore, we are reaching out to ask the state to ensure parity of resources similar to that available for inpatient care. We are asking for resources that will provide for an increase rapid testing capacity for all outpatient services, including but not limited to, ambulatory surgical care facilities, private practices, and clinics.
