Flexibility Options in the Distribution Grid

The role of distribution grids is evolving. Regulators and distribution grid operators face an array of unprecedented responsibilities and opportunities, associated with the rapid increase of intermittent distributed energy sources, new digital technologies, and demand response.

The United States and Europe face many common questions on the road towards a smarter and more flexible distribution grid: How can we increase grid flexibility and resilience in the most economical way? What are the tradeoffs between digitalization and cybersecurity? How can the costs of grid modernization be allocated amongst stakeholders?

With the goal to better understand and navigate a new reality of grid operation needs, the German Federal Ministry for Economic Affairs and Energy ([BMWi](#)) **invites you to participate in a transatlantic thought leader exchange**. The trip is part of a broader scale effort to strengthen the energy cooperation between our countries, encourage the exchange of ideas, and build energy transition policy expertise.

This knowledge exchange aims to provide intelligent solutions for distribution grid architecture, rate design, the integration of distributed energy sources, electric vehicles, and demand flexibility. It offers the opportunity for multi-stakeholder executives to jointly explore avenues towards the grid of the future.

Planned activities

The program entails a combination of:

- **Presentations** on the regulatory, technical, and economic issues facing the power distribution grid in Germany. The US delegation will visit relevant ministries and important stakeholders.
- **Meetings** and peer-to-peer exchange between grid modernization executives from the US and Germany. You will meet major distribution grid actors and energy experts from the administration, regulators, and utilities.
- **Site visits.** The participants will visit flagship projects in Berlin.
- **Identify actions** for continuing cooperation through workshops at the beginning and end of the trip.
- The trip aims to **deepen the dialogue** started during previous energy policy exchanges. Both new and previous participants are invited to join.

Trip layout

- Duration of the program is four days, from Monday, May 6 to Thursday, May 9, 2019. Travel to Berlin is planned for Sunday, May 5, departure for Friday, May 10, 2019.
- A small group size of up to **15 participants** will ensure an individualized experience and an optimum group dynamic.
- The programming will be in English, with bilingual staff on-site for language support.
- Participants will receive short profiles about the visited institutions and sites prior to the trip.

Program cost and coverage

- The trip takes place upon the **invitation of the German Federal Ministry for Economic Affairs and Energy**.
- This includes the **facilitation of all meetings, ground transportation, and select meals** (all lunches and one welcome dinner) within the scope of the program.
- Participants are responsible for their own airfare to and from Germany (~\$1,000.00), their accommodation (~\$110/night incl. breakfast for 3*** hotel) and for meals that are not part of the official program.
- **There is no separate program fee.**

Knowledge-exchange between US and German power system operators

Please read the following statements carefully and indicate your agreement to the terms by signing below.

I hereby acknowledge and agree to the following terms:

1. I hereby confirm my participation in the delegation, starting on **Monday, May 6, 2019** and ending on **Thursday, May 9, 2019**, organized by RENAC and the German American Chambers of Commerce (hereinafter "Program Organizer") on behalf of the German Federal Ministry for Economic Affairs and Energy.
2. I am aware of the intensive nature of the program's agenda and agree to fully participate in all modules therein to the best of my ability. Typical program days will begin no later than 8:00am and end no earlier than 8:00pm. This will include conferences, site visits and networking events, and travel by bus and/or walking up to 30 minutes at a time. Every participant is responsible for being on time for all parts of the program.
