Customers will be given the option to have an in-home assessment or to have the assessment done remotely using video technology. For in-home assessments the amount of time the auditor spends inside the home will be shortened and we will be following up with call to review the report and recommendations and prioritize a short- and long-term savings plan.

Customers who perform assessment will receive energy saving items such as LED bulbs, smart power strips, and water saving devices that are installed at the time of the assessment. For those customers who choose to have a video assessment, energy saving kits will be delivered at a later time.
