To achieve its goal, the GAC must develop, coordinate and expedite an annual comprehensive and pro-active plan for all government affairs initiatives, for review and approval by the Board of Directors of AIA Michigan. The GAC is not a policy-making body. The charge of the GAC is to investigate, debate, and recommend actions to the AIA Michigan Board of Directors that advance the interests of the profession, protect the health safety and welfare of the public, and are consistent with AIA National policies. Upon receipt of final direction from the AIA Michigan Board, the GAC will implement the policies, taking necessary and reasonable measures within its authority.

### **Honor Awards**

All Architects in Michigan are invited to submit their best work for consideration in a juried design awards program. This prestigious competition has, for over 45 years, sought to honor and embrace the creativity, diversity and architectural excellence of Michigan architects. Members are encouraged to nominate individuals whose accomplishments have helped to foster healthy, safe and sustainable communities through good design. The committee plans the event and brings new ideas as well as fundraises.

### **Mid-Summer Conference**

For 75 years Architects, designers, contractors and firm leaders gather each year for the annual Mid Summer Conference on historic Mackinac Island. AGC has partnered with AIAMI for the past 11 years. This conference provides continuing education as well as family events. Committee members participate in gathering continuing education ideas, events and fundraising.
