





To best care for one another, 301 Faith Partners includes these policies as we navigate the reality of COVID-19. Please remember, these policies are in effect regardless of vaccination status. Even if you and/or everyone in your group are vaccinated you are still required to follow this policy.

Our building use and masking policies will follow the current CDC and Larimer County Guidelines at the minimum. Those Larimer County guidelines are available at the Larimer County Covid-19 Dashboard, and fall into one of three categories:

Dashboard Level	Our Response
Green	No restrictions on masking, distancing, or capacity, but masks are still encouraged. Groups can form agreement on mask usage as they deem appropriate.
Yellow	Masks are required, in-person capacities will be limited (see below), and social distancing will be strongly encouraged. No shared food or drink, including coffee. Individually packaged or personal food/drink items are acceptable, including for funerals and special events. Holy Communion will be served as approved by governing bodies and congregational leadership. For worship leaders, mask use is optional for spoken worship sections.
Red	All events, programs, and services online. No building usage by outside groups.

## Guidelines for Positive Test or Exposure to Covid (more at cdc.gov):

Exposure to COVID no longer requires quarantine if you are fully vaccinated.

If staff are experiencing symptoms, or test positive they are required to quarantine for 10 days or present a negative test upon returning to work or use of the building.

If congregational members test positive, please notify the church office. We strongly encourage members to quarantine for 10 days and pass a negative COVID test before using the building, volunteering, or being in worship.



## Restricted Building Capacities/Responsibilities Under Yellow Condition:

- The Sanctuary will be limited to 125 persons and the fellowship hall capped at 50.
- Small Meeting Rooms (Rm 2, Rm 5, Rm 9, Sunroom, Fireside Library, Choir, Bells) will be available for use by 301 Faith Partners. The room will be limited to 3 meetings per day, with 3-hour spacing in-between meetings. No more than 15 in the room at any time.
- Elective groups including recitals, concerts, AA, NA, etc. will be allowed per the above guidelines, and at the discretion of the building manager, staff, and/or church leaders.
- Groups are required to clean the space after use, including wiping down surfaces, door handles, chairs, etc.

## **Music Protocol for Worship Recording under Red & Yellow Conditions:**

- Solo Piano/Organ no mask
- Piano with solo vocalist Pianist masked, Vocalist not masked and 6 ft min. away from pianist
- Piano with multiple vocalists Separate mics; 6 ft min. apart, with masks.
- Piano with non-wind instrument both masked; 6 ft min. apart, with masks.
- Piano with wind instrument Pianist masked, Instrumentalist not masked, bell cover for instrument, and a minimum of 10 ft distance from pianist

## **Guidelines for Masks:**

Surgical, Filtered, N95, or KN94 masks are recommended, rather than cloth masks.
