

**Ann & Nate Levine Academy COVID-19 Health and Safety Procedures**  
**Summer Program 2020**

As we prepare to open our school for Camp Shemesh & Summer@ Levine at the Ann & Nate Levine Academy (“Levine Academy”) during the COVID-19 pandemic, we are implementing the following Health and Safety Procedures to help reduce the spread of COVID-19 during the summer programming. While Levine Academy will attempt to follow the guidelines from the State of Texas and the Centers for Disease Control, many of the safety precautions recommended (i.e. face masks, social distancing, and avoiding direct contact) are not possible or feasible with young children. Furthermore, while we are requesting that all participants follow these Health and Safety Procedures, Levine Academy cannot guarantee that any parent and/or child will not become infected with COVID-19 during or after coming to the campus. While it is not possible to eliminate all risks of spreading the virus, these Health and Safety Procedures are being put in place to attempt to reduce these risks. Furthermore, these procedures may be amended or updated based on any additional guidance, local or state orders, and/or changes in public health conditions. Participation in the summer programs are completely voluntary. In addition, Levine Academy, in its sole discretion, may close or cancel any or all of its summer programs, temporarily or permanently, based on changing public health conditions and/or any local, state, or federal requirements. Please read the following information carefully as you will be required to follow these procedures each day. **Morning Student Drop Off Procedure and Screening/Certification Process**

Each morning, Levine Academy staff will conduct a drive-through screening procedure prior to class time. You will be met by a staff member wearing personal protective equipment who will take your child’s temperature using non-contact (temporal) thermometers. The staff member will record the child’s temperature on a daily certification chart. The staff member will then ask you questions related to COVID-19 symptoms and certifications that we must ask every day. Once your child is cleared to enter class for the day, your child will be removed from your car and taken into class. Families who arrive after their designated drop-off and screening window time will need to call the front office and a member of the staff will meet you outside.

Parents will be required to wear a face covering/mask during the entire time they are on the Levine Academy campus, including during the drive-through screening procedure. Please put on your mask before entering the Levine Academy parking lot. Parents should not enter, or exit through, the school building unless approved by school staff.

1. Neither I, nor my child, nor a member of our household, has been lab-confirmed, nor are we waiting for a lab confirmation, of a COVID-19 infection;
2. At the time of arrival and for at least 10 days prior to arrival, neither I nor my child have experienced any of the following signs or symptoms of possible COVID-19: cough, shortness of breath, difficulty breathing, chills, repeated shaking with chills, muscle pain,

headache, sore throat, loss of taste, loss of smell, diarrhea, feeling feverish or a measured temperature greater than or equal to 100.0 degrees Fahrenheit.

3. At the time of arrival, neither I, nor my child, nor any member of our household, has had known close contact with a person who is lab-confirmed to have COVID-19 within the last 14 days, someone who is under investigation for COVID-19, or someone who is ill with a respiratory illness; or,
4. Neither I nor, my child, nor a member of our household, has traveled internationally within the last 14 days to countries with ongoing community transmission. For updated information on affected countries, visit: <https://www.cdc.gov/coronavirus/2019-ncov/travelers/map-and-travel-notices.html>.

If you cannot agree and certify to all of the above statements each and every day, you and your child will not be allowed to come to campus until the conditions above regarding COVID-19 are met.

### **Class Size and Grouping**

- Each class will be limited to the following number of students and staff:
- Each individual (teacher, staff, or student) must have a minimum of 45 square feet of space in the classroom
- The groupings in each class will be consistent (i.e. the same students with the same staff members every day) and the students will remain in the same group for the entire time
- There will be no mixing of groups.
- Students will remain in their assigned classrooms and will not rotate to other rooms or areas in the building except to go outside to the playground. Specials teachers (i.e. music) will conduct activities in the classroom and will sanitize hands and all equipment used between classes.

### **Hygiene in the Classroom**

- Staff and students will be instructed in good handwashing techniques and will be required to wash or sanitize their hands regularly throughout the camp day as follows:
  - Immediately upon arrival
  - After coming into contact with bodily fluids (including after sneezing and coughing)
  - Before playground time
  - After playground time
  - Between activities as needed
  - After touching something another person touched, as needed
  - Anytime the student/staff leaves the classroom
  - Anytime the student/staff enters the classroom
  - Before eating/handling food
  - After eating/handling food
  - After using the restroom or having a diaper changed
  - Before leaving for the day
- Students will not be required to wear masks but encouraged to do so, where feasible.
- No visitors will be allowed in the classrooms, including parents.

- All adults in the classroom will wear Personal Protective Equipment (PPE), including masks and gloves, if necessary.
- By the very nature of young children, they cannot (and should not) be distanced. This means that teachers and other classroom assistants will provide normal care and affection to your child and will be in close physical proximity.
- Children will also be interacting closely with their peers throughout their time at school.

### **Sanitation of Classroom Environment and Materials:**

- Classroom materials will be either sanitized daily or placed into a 36-hour rotation. This includes books. Items in rotation will be stored in closed boxes and will be cleaned between uses.
- Each student will have their own supply box of basic materials such as pencils, markers, crayons, scissors, glue sticks. These items will not be shared.
- Cloth toys or toys that cannot be readily sanitized will not be used.
- Classroom surfaces such as tables, chairs, doorknobs, light switches, sink handles, countertops, bathroom facilities, and cubbies will be cleaned by staff during playground time.
- Classroom surfaces and common areas will be cleaned nightly.

### **Meals and Snacks**

- Students must bring their own lunches and water bottles. Students will not be allowed to refill water bottles. Water bottles may be refilled only by a staff member.
- Food and/or water bottles are not to be shared.
- Students will eat in their classroom.
- The school will supply snacks that are prepared by staff in accordance with food preparation procedures and will be distributed to each child by their teacher, who is wearing gloves and a mask.

### **Teachers and Staff**

- Teachers will be required to take a 2-hour course on infection control during COVID-19.
- Teachers and staff will fill out the health check daily and have their temperature taken before moving to their classroom or assigned duties.
- Teachers and all staff will wear masks over the nose and mouth at all times, when feasible.
- Teachers and staff who have close physical contact with children will have a covering for their clothes to ensure no bodily fluids are transferred.
  - Staff will have several of these coverings for multiple changes
  - The coverings will be washed daily
- Classes will have an assigned assistant who has limited contact with other staff and children.
- Classroom assistants will be preassigned and stay with one or two groups only.

- Classroom assistants will help teachers in ongoing health and hygiene practices such as thorough hand washing, disinfecting of tables and touched classroom items, and bathroom sanitation.

### **Utilization of the Outdoors**

- The outdoors will be used to the extent possible.
- Outdoor learning can be utilized with scheduled, staggered times and keeping a 30-foot distance between groups.
- Playground time will be scheduled so that just one class at a time is on the playground. Certain playground equipment, such as plastic or metal grab bars and railings, will be cleaned routinely.

### **Pick-Up Time**

- At the conclusion of the summer camp day, children will be picked up outside by their parent or caregiver outside in the carpool. No parents will be allowed inside the building.
- Parents/caregivers should again, wear masks and stay in their cars while waiting for their child to exit the classroom.

### **Risks of Exposure and Self-Isolation Requirements**

- COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. Research from the Centers for Disease Control, among others, has found that while children do get infected by COVID-19, relatively few children with COVID19 are hospitalized. However, some severe outcomes have been reported in children, and a child with a mild or even asymptomatic case of COVID-19 can spread the infection to others who may be far more vulnerable.
- We are aware that some children may be participating in summer activities at other schools or programs. For this reason, we ask that all families be particularly mindful of health practices outside of the school. This includes being conscientious about monitoring their child's health and any possible symptoms. Additionally, it is very important that children not be sent to school if they have a fever. Children who appear ill or develop symptoms at school will be isolated immediately and sent home. For this reason, we ask that all families be particularly mindful of health practices outside of Levine Academy.
- We recognize that children can develop fever for reasons not related to COVID-19. Nevertheless, it is critical that children be kept home if they have a fever and not return to school until the conditions below regarding COVID-19 symptoms are met.
- An individual (student, teacher, or staff) who experiences any of the symptoms of COVID-19 while at Levine Academy will be immediately isolated and sent home. The area utilized will be closed for 24 hours and disinfected.
- If a parent, student, or staff member believes they have had close contact with a person who is lab-confirmed to have COVID-19, this person is not allowed to be on our premises until the

end of the 14 day self-quarantine period, or they have a note from a medical professional clearing the individual to return.

- If a positive case is identified for a summer school participant, whether teacher, staff, or student, the school will identify any individuals who had regular or close contact with the affected participant and notify them in writing. This will include the entire class (students, teachers and staff) and potentially other teachers and staff (if multiple teachers work regularly with the student or staff member). If those teachers or the students interacted with other students or staff on a regular basis or came in close contact with them, those students and staff should be considered potentially exposed as well and will be screened for symptoms and tested for COVID-19 before returning to school.
- Any teacher, staff member, or student who experiences any of the symptoms of COVID-19 listed below should self-isolate until the following conditions have been met:
  - Where an individual has been diagnosed with COVID-19, the individual may return to school when all three of the following criteria are met: (1) at least 3 days (72 hours) have passed *since recovery* (resolution of fever without the use of fever-reducing medications); and (2) the individual has improvement in respiratory symptoms (e.g., cough, shortness of breath); and (3) at least 10 days have passed since *symptoms first appeared*; or
  - Where an individual who has symptoms that could be COVID-19 (including a fever) and does not get evaluated by a medical professional or test for COVID-19, the individual is assumed to have COVID-19, and the individual may not return to the school until the individual has completed the same three-step criteria listed above; or
  - Where an individual has symptoms that could be COVID-19 and wants to return to school before completing the above self-isolation period, the individual must obtain a medical professional's note clearing the individual for return based on an alternative diagnosis.
- Any student, teacher, or staff member living with someone who experiences any of the symptoms of COVID-19, whether they have a positive COVID-19 test or not, should self-isolate until the above conditions have been met. If they do not experience any COVID-19 symptoms during that period, they can return to summer school. If they experience symptoms, they must self-isolate until the conditions outlined above have been met.

### **COVID-19 Symptoms**

- Cough
- Shortness of breath or difficulty breathing
- Chills
- Repeated shaking with chills
- Muscle pain
- Headache
- Sore throat
- Loss of taste or smell
- Diarrhea
- Feeling feverish or a measured temperature greater than or equal to 100.0 degrees Fahrenheit
