### **HB 0121** Florida Kidcare Program Eligibility by Bartleman

Florida Kidcare Program Eligibility: Increases income eligibility threshold for coverage under Florida Kidcare program; requires applicant seeking coverage under program to provide specified documentation under certain circumstances; requires that premiums for certain enrollees under program be based on tiered system of uniform premiums. Effective Date: July 1, 2023

### **SB 0058** Public Records and Meetings/Psychology Interjurisdictional Compact by Harrell

Public Records and Meetings/Psychology Interjurisdictional Compact; Providing an exemption from public records requirements for certain information held by the Department of Health or the Board of Psychology pursuant to the Psychology Interjurisdictional Compact; providing an exemption from public meeting requirements for certain meetings of the Psychology Interjurisdictional Compact Commission; providing for future legislative review and repeal of the exemptions; providing a statement of public necessity, etc. Effective Date: On the same date that SB 56 or similar legislation takes effect, if such legislation is adopted in the same legislative session or an extension thereof and becomes a law

### **SB 0056** Psychology Interjurisdictional Compact by Harrell

Psychology Interjurisdictional Compact; Enacting the Psychology Interjurisdictional Compact; providing for recognition of psychologist licenses in compact states; providing that, while authority over a psychologist's license remains with the home state, receiving states and distant states may define the scope of and act on a psychologist's authority to practice in the receiving or distant state, as applicable, under the compact; requiring the Department of Health to report certain investigative information to the coordinated licensure information system, etc. Effective Date: 7/1/2023

Step-therapy Protocols; Defining the term "serious mental illness"; requiring the Agency for Health Care Administration to approve drug products for Medicaid recipients for the treatment of serious mental illness without step-therapy prior authorization under certain circumstances, etc. Effective Date: 7/1/2023

#### Victims of Crimes of Sexual Violence or Sexual Exploitation by Berman

Victims of Crimes of Sexual Violence or Sexual Exploitation; Providing that a victim of any crime of sexual violence or sexual exploitation has the right to prevent any person or entity from disclosing or disseminating information or records that might identify him or her as a victim of such crimes; prohibiting a person or an entity in possession of information or records that might identify an individual as a victim of a crime of sexual violence or sexual exploitation from disclosing or disseminating such information or records without first obtaining the express written consent of the victim; authorizing an aggrieved person to initiate a civil action for an injunction against certain persons or entities after following specified procedures, etc. Effective Date: 7/1/2023

#### Emergency Opioid Antagonists by Edmonds

Emergency Opioid Antagonists: Requires Florida College System institutions & state universities to have supply of emergency opioid antagonists in certain residence halls & dormitories for use by specified employees; provides requirements for placement & accessibility of emergency opioid antagonists & training; provides specified immunity from liability. Effective Date: July 1, 2023

Effective Date: on the same date that HB 33 or similar legislation takes effect

Psychology Interjurisdictional Compact: Creates Psychology Interjurisdictional Compact; authorizes specified psychologists licensed in compact states to practice telepsychology & practice temporarily in other compact states; provides for construction, severability, rulemaking, & state enforcement. Effective Date: July 1, 2023

**HB 0061****Medicaid Expansion through a Medicaid Buy-in Program** by Harris

Medicaid Expansion through a Medicaid Buy-in Program: Requires AHCA to establish & implement Medicaid buy-in program for certain individuals with disabilities; provides requirements for program; requires agency to seek federal waiver approval or submit any state plan amendments necessary to implement program by specified date; requires agency to implement program upon receiving federal approval. Effective Date: upon becoming a law

Health Insurance Cost Sharing; Requiring specified individual health insurers and their pharmacy benefit managers to apply payments by or on behalf of insureds toward the total contributions of the insureds' cost-sharing requirements; requiring specified contracts to require pharmacy benefit managers to apply payments by or on behalf of insureds toward the insureds' total contributions to cost-sharing requirements; requiring specified group health insurers and their pharmacy benefit managers to apply payments by or on behalf of insureds toward the total contributions of the insureds' cost-sharing requirements; requiring specified contracts to require pharmacy benefit managers to apply payments by or on behalf of insureds toward the insureds' total contributions to cost-sharing requirements, etc. Effective Date: 7/1/2023
