Juneteenth Day	Wednesday	June 19, 2024	Full-time employees are eligible for a maximum of 8 hours of Juneteenth Day Holiday Pay. Part-time employees are eligible for a prorated amount based on their normal weekly schedule.
Independence Day	Thursday	July 4, 2024	Full-time employees are eligible for a maximum of 8 hours of Independence Day Holiday Pay. Part-time employees are eligible for a prorated amount based on their normal weekly schedule.
Labor Day	Monday	September 2, 2024	Full-time employees are eligible for a maximum of 8 hours of Labor Day Holiday Pay. Part-time employees are eligible for a prorated amount based on their normal weekly schedule.
Thanksgiving Holiday*	Thursday	November 28, 2024	Full-time employees are eligible for a maximum of 16 hours of Thanksgiving Holiday Pay. Part-time employees are eligible for a prorated amount based on their normal weekly schedule.

- b) Taking PTO to supplement their scheduled hours to fulfill their FTE hours for that week.
