We help shape the character of our youth, and every child and young adult, in the Roaring Fork Valley, interested should be able to take advantage of the opportunities we provide, regardless of their financial situation. Because our funds are limited, scholarship assistance will be contingent upon financial need. Please understand that all AVSC participants receive a form of financial aid since program fees represent only 60% of the true cost of providing these programs.

Competitive program applicants are eligible for up to 50% of program fees. In special circumstances, we may be able to offer more than 50%. Scholarship applicants should also thoroughly understand the conditions that accompany the receipt of an award.

### CONDITIONS FOR SCHOLARSHIP AWARDS

---

All participants receiving a scholarship must meet the following conditions. Failure to meet these requirements will result in the forfeiture of the scholarship award.

- Recipient must abide by the AVSC Code of Conduct, be a resident of the Roaring Fork Valley or Western Garfield County.
- All recipients will be required to write a letter of thanks on behalf of AVSC (post-season, details to follow).
- A copy of the letter of thanks must be sent to AVSC to be eligible for scholarship in the following season.
- All past balances must be paid in full.

- Scholarship Application Form** - Only one form is required per family.
- 2018 Tax Returns – Two-parent households filing separate returns must attach 2018 tax returns from both individuals to be considered. All information is confidential.**
- Explanatory Letter** - On a separate sheet, please inform the scholarship committee as to why you are requesting a scholarship and what receiving a scholarship will mean to you. Include comments on any special circumstances influencing your financial position which AVSC should consider in the decision-making process.
- Completed online registration and deposit paid**
