YOU MUST PROVIDE PROOF OF INSURANCE naming the CITY OF STANWOOD **AND** TWIN CITY IDLERS as the Certificate holder. **The City of Stanwood Requires that ALL Vendors have at least \$1,000,000.00 (one million) for each occurrence and \$2,000,000.00 (two million) general aggregate.** You **must** also provide us/city with a current copy of your Food handler's permit.

Auto Dealers: Cars in your vendor area are **NOT** eligible for trophies.

Food Vendor - It is **YOUR RESPONSIBILITY** to know what the "Requirements to operate at temporary events" are. We will not refund your money if the health department shuts you down the day of the show, OR you do not have the proper paperwork filed. Snohomish Co. Health Dist. **REQUIRES** you to obtain a Temporary Food Service Permit, 7 days prior to the event for more information call: Environmental Health Division, Food Section, Everett, WA, @ 425-339-5250. You also need a food handler's permit as well.

We have paperwork that we must provide to the city 30 days before the show.
