Job Summary: The Peer Support Specialist is a vital team member of the ARC of Hope program. This person will intervene to provide emotional and social support, active listening skills for providing non-judgmental opinions, sharing experiences and navigation of health resources to help others to gain and or sustain recovery from an active substance use disorder. Under the supervision of the ARC of Hope staff, the Peer Support Specialist will be responsible to assist individuals who are struggling with substance abuse to engage in treatment, serve as an advocate, offer support, coordinate services, to connect the individual to treatment and support groups, provide education, and participate in outreach events. The Peer Support Specialist will work

with the individual to remove personal and environmental obstacles to access substance abuse treatment services. The Peer Support Specialist will demonstrate effective communication skills and have fluent computer skills using MS Word and an application to create a database to track case management.
