- Operating cash balance of \$75,096 at April month-end, \$9,201k lower than the prior month.
- General giving income for the month of April was \$16,723.
April YTD general giving income of \$86,504 is \$9,454k or 12% under plan.
- Total operating revenue for the month of April was \$20,269.
April YTD's total operating revenue of \$137,241 is \$18,184 over plan.
- Total operating expense for April 2022 was \$26,384.
April YTD total operating expense of \$106,939 is \$11,300 or about 11.9% above budget.
Utilities are running about 50% above budget and are projected to finish the year at \$12-15,000 over budget.
- The organ loan monthly payment of \$1,456 was made on 4/4/2022
As a result, the remaining principal balance on the loan is \$109,194.
- Organ fund month-end cash balance in the Emmanuel bank account was \$31,671.
Including the Friends of Casavant account (\$29,365), the total organ fund cash balance was \$60k.
