### **Quick Recap**

- 1. Operating cash balance of \$64k at October 2021 month-end, \$3k lower than prior month.
- 2. General giving income for the month of October was \$21k.October YTD general giving income of \$179k is \$6k below budget.
- 3. Total operating revenue for the month of October was \$24k.October YTD total operating revenue of \$263k is \$22k over budget.
- 4. The total operating expense for the month of October was \$27k. October YTD total operating expense of \$208k is \$31k below budget.
- 5. The air conditioner repair bill (\$8,600) was paid to Dahme Mechanical Industries. The Major Maintenance restricted fund was used to pay the bill.
- 6. The organ loan monthly payment of \$1,456 was made on 10/5/2021. The remaining principal balance \$128k.
- 7. Organ fund month-end cash balance in the Emmanuel bank account was \$24k. Including the Friends of Casavant account, the total organ fund cash balance was \$54k. Note that a portion of this cash must be held in reserve for potential refunds for the canceled Notre Dame choir concert

# C. POP Report

- 1. As of the beginning of November, we had about \$25K in the EEC organ fund and \$30,340 in the FOC fund for a total of about \$55K. Approximately \$15K of this total needs to be held in reserve to make any refunds of Notre Dame tickets.
- 2. The remaining loan principal is \$129,094 as of 9/30.
- 3. Concert Series: We felt that the silent movie event was very successful. We had about 100 attendees () and collected over \$1000 on concert night for tickets and refreshments. In addition, we sold 60 tickets online at \$10 each. Our net profit is at least \$1200-1300.
- 4. Next up: Patricia Barber (Jazz trio) plus LT Big Band Friday, 1/21/22 at 7:30pm. Tickets are \$20 per person and ½ price with a school ID. Kaia string quartet plus LT Chamber Group Friday, 3/11/22.
