1. Formation

- a. Call to Order – 7.08 pm
- b. Opening Prayer by Ellen Ekevag

2. Information

- a. October Minutes – Motion by Lisa Enright to approve October minutes.  
Seconded by Vicki Roe. Motion Carried by all

- b. Treasurer's Report – Larry Brongel

Initial query about an amount of \$2,057.05 showing on the report, for special event expenses under the actual expenses for October. The same amount was found on page 8, as an unallocated Visa Bill amount.

Cindy Mottl voted to accept the treasurer's report. Dorren Gertsen-Briand seconded. The report was unanimously accepted.

c. Individual Reports

- i. Senior Warden – Cindy Mottl

Cindy asked that the vestry support the concerts during the upcoming concert series. Also we had a report of a bed-bug issue, and had agreed to have a sniffer dog in the church and buildings, the payment contract needed to be sent that night. \$400. All agreed

A motion was made to purchase a floor buffer for Clarence to be able to strip and re-wax the floors throughout the building, hopefully before Christmas. See Motion 1.

George Tarasuk had news of new art/performance grants now available for groups wanting to perform here, with good opportunities.

Comfort height toilets were discussed, not all of our toilets are 'comfort' height creating difficulties for our elderly/infirm and disabled visitors.

Meredith reported that the Youth Group is not well attended and therefore it was put forward that their youth room (Swamp kitchen) be repainted in more youth friendly colors.

The Advent evening series is designed around death; planning for it, personal information, not meant to be morbid, just practical. Dave asked that people attend, only the first night will be religiously based.

Also at the recent convention, an amendment was suggested to lower the voting age for Vestry members within the vestry from 18 to 16. We will vote for the change to be implemented at the Annual Meeting.

Motion 5 – Cindy M moved to update the church bank details to reflect the new Wardens for 2018, to add Andy Dolliff, as Junior Warden and remove Cindy Mottle, & update Sue Jasiak as Senior Warden. Jean E seconded. All agreed.
