B. Budget 2023

A lengthy conversation about the budget led to a number of modifications in various categories. The final result was a deficit budget of \$14,995, although the Vestry believes that this is a conservative estimate and expects to do significantly better. Of note, the budget included money to purchase speakers for meetings and outdoor services, as well as allowing Rev. Dave to carry over his continuing education funds which were unspent in 2022. This budget was moved by Drew Beyer, seconded by Kathy Lampert, and approved in a voice vote. In addition, one modification was approved via email following the meeting after receiving updated information on the KAC, and that reduced the forecast deficit to \$10.495.

Treasurer's Report (Full report)

Summary of December Report

- 1. Operating cash balance of \$58,128 at December 2022 month-end, \$13,488 higher than the prior month.
- 2. General giving income for the month of December was \$47,505 December YTD general giving income of \$242,462 is \$11,312 or 4.9% over plan. Donations for window refurbishment are being separately tracked and total \$5,643.51 as of December 31 (+\$20 in Dec).
- 3. Total operating revenue for the month of December was \$51,355. December YTD total operating revenue of \$337,528 is \$47,418 or 16.3% over plan.
- 4. The total operating expense for December 2022 was \$35,068. December YTD's total operating expense of \$320,018 is \$33,201 or about 11.6 above budget.
- 5. The organ loan monthly payment of \$1,456 was made on 12/5/2022. As a result, the remaining principal balance on the loan is \$100.852 as of 12/31/2022
- 6. The organ fund month-end cash balance in the Emmanuel bank account was \$64,338. Organ restoration and antiphonal funds contributed during the month were \$548 and \$17,551 respectively, YTD \$20,254 and \$79,091.
