| 10:35 AM-11:30 PM | Discussion of the New Companion Animal Care Standards Act 1 CLE; Skills <i>Libby Post and Melissa Gillespie, Esq.</i> On December 15, 2025, the Companion Animal Care Standards Act for Shelters and Rescues will take effect. Passed and signed into law by Governor Hochul in December 2022, the bill will raise the standard of care for homeless companion animals at shelters and rescues across New York State. All shelters and rescues will be licensed as animal shelters and will be inspected by the New York State Department of Agriculture and Markets. The new standards are based on the Association of Shelter Veterinarian 2010 guidelines. These same guidelines are used for the Companion Animal Capital Fund which will also be discussed and has so far invested \$33M in capital improvements at animal welfare organizations throughout the state. |
