2018 Action on Behalf of Children Awards

Nomination Category Criteria

NOTE: Please address each bullet point specific to nominee's category when completing the nomination form.

CHILD CARE PROVIDER / CENTER: *The category recognizes individuals & businesses who provide early childhood care and education, including Family Child Care Homes and Child Care Centers. The nomination may be for an individual or a business.*

- How long has the individual or business been providing child care in our region?
- For businesses, describe the structure and size of the business and why it warrants recognition. For individuals, describe their role in the business and why they warrant recognition.
- What unique programs and services are provided by the individual/business, including those for children with special needs?
- Please describe how the individual/business represents and promotes quality child care. What other activities does the business/individual participate in that support quality child care in our region/state?

CHILD ADVOCATE: *The category recognizes an individual who has advocated for children through their work, volunteerism, or both.*

- In what capacity does the individual exhibit exceptional effort as a children's advocate? Is the work performed as an employee, volunteer, or both?
- Describe the quality and quantity of work. How long has the individual advocated for children? How many children have benefited from the individual's efforts? Does the individual also advocate for children with special needs?

CHILDREN'S HEALTH: *The category recognizes exemplary efforts by a health care professional or organization whose efforts benefit the health and well-being of children.*

- Describe the health education activities or efforts that the organization/individual has participated in that improved the health of children.
- How has the organization/individual promoted or supported the health of young children?
- How is the health of our region's children/families improved because of their efforts?
- Describe the organization's or individual's quality of health care service delivery for children including those for children with special needs.

KIDS HELPING KIDS: *The category recognizes exemplary efforts by a child/group of children whose efforts benefit other children. Nominations must be for children ages 8 years to 18 years of age.*

- Please describe the activity or activities undertaken. How did the activity benefit other children?
- Describe how children were leaders in the effort.

BUSINESS: *The category recognizes a for-profit business who has supported the needs of children through unique and/or exemplary actions.*

- In what capacity has the business benefited children?
- Describe the quality and quantity of work performed.
- How long have these exemplary efforts been occurring? How many children have been affected?
- How are our region's children/families stronger because of their effort?

PUBLIC AGENCY / SCHOOL: *The category recognizes an institution for their work to support the needs of children and advocate on behalf of children in our region.*

- In what capacity has the institution served children?
- How has the institution represented the needs of children through their actions, policies, and efforts?
- Describe the quality and quantity of work performed. How long have these exemplary efforts been occurring? How many children have been affected?
- How are our region's children/families stronger because of their effort?

NONPROFIT ORGANIZATION: *The category recognizes a program or project of a nonprofit organization that benefits children in our region.*

- In what capacity does the organization serve children? Please describe the specific program/project which should be recognized.
- How has the organization represented the needs of children through their actions, policies, and efforts? Please provide specific examples.
- Describe the quality and quantity of work performed. How long has the program/project been implemented? How many children have been affected?

MEDIA: *The category recognizes exemplary efforts by a media source to promote the needs and challenges of children, families, and/or child care providers in our region.*
