




## New Board gets to work

Applicants for this vacancy will be considered at the June 27, 2023 board meeting.



[Know Overdose Nevada County](#) is a local campaign to increase knowledge and awareness about drug overdose risks. The campaign employs [harm reduction strategies](#) to help prevent overdoses and deaths. The campaign goals are:




1. Prevent deaths from drug overdoses
