## **Cohort 1: Vaccine Methodologies and Legalities**

Led by Attorneys General Wasden (ID) and Ferguson (WA) that will focus on the methodology and legality of a potential COVID-19 vaccine. More specifically, this Cohort will consider the state's role in distribution, including legal obligation of accepting the federal government mandates and lessons learned from testing; whether states can use their own definitions for early phase vaccine recipients; liability issues including the scope of the Prep Act; and litigation preparedness.
