

ROOMS


CWAG has a block of rooms reserved at The Royal Hawaiian at a discounted rate of \$315 per night for a historic garden view room and \$425 per night for an ocean view room plus 13.962% tax. Existing bedding consists of one (1) king bed or two (2) queen beds. Reservations will be guaranteed with a one (1) night's deposit. The room block is very limited. The cut-off date to reserve rooms at the discounted group rate is Friday, February 10, 2017 or until the room block is sold out whichever comes first.

Meeting attendees have access to complimentary wireless high-speed internet access, local telephone calls, toll-free telephone access, use of the 24-hour fitness center and in-room coffee and water.
