### **Hemp & Hemp-Derived Products: Legal Challenges Following the 2018 Farm Bill**

The 2018 Farm Bill carved hemp and hemp derived products under 0.3% THC from the definition of marijuana under the Controlled Substances Act. As a result, the national marketplace for hemp and hemp derived products is booming. However, challenges remain in hemp cultivation programs, confusion over hemp derived products regulation and safety standards, and there is a lack of enforcement resources. This discussion will focus on the developments in federal and state law to clarify the hemp regulatory landscape, enforcement practices to reign in bad actors, and best practices in product manufacturing and testing standards.

**The Colorado River: “Adapting to the 21<sup>st</sup> Century”**

Almost one hundred years ago, the Colorado River Compact brought together the seven Colorado River Basin States (Arizona, California, Colorado, Nevada, New Mexico, Utah, and Wyoming) and the federal government to allocate the most significant water source in the most arid regions of the country. Throughout the 20th Century the federal government built large-scale water storage projects on the Colorado River to harness its water for irrigation, power, flood control, domestic, and municipal use. The Colorado river governance process is designed to allow for Colorado River basin states to utilize their apportionments and fulfill settlement obligations with various Tribes. Yet, a multi-decade drought, and massive population growth in the Colorado River Basin are creating new challenges in providing a sustainable water supply for the Basin States and tribes alike. This panel will discuss how the states, the federal government, tribes, water users, and stakeholders are working cooperatively to meet the water supply demands of the 21st Century.

National security and siting of oil and gas pipelines has garnered a lot of recent attention as the United States ramped up domestic production. Recent litigation and federal policy changes are continuing to reshape the energy and regulatory environment. Patrick Hester will review shifting regulatory requirements related to national security, climate change, federal and state permitting under the Clean Water Act, as well as the Supreme Court's recent review of eminent domain authority under the Natural Gas Act. State Attorneys General and environmental agencies have been combating widespread contamination of drinking water and other natural resources from per- and polyfluoroalkyl substances (PFAS) for several years. With a rapidly growing understanding of the risks and impacts of PFAS on human health and the environment, a significant number of states have brought claims to remediate these chemicals, treat drinking water contaminated with PFAS, and restore their state's natural resources. Bill Jackson will provide an overview of the litigation, regulations and related efforts to address PFAS contamination across the country.

Almost 95% of teens expressed or experienced violent subject matter or thoughts via social media. More than two-thirds of teens engaged in conversations about depression or were involved in a self-harm/suicidal situation via social media. 77% of tweens experienced bullying as a bully, victim, or witness via social media. Almost 90% of teens encountered nudity or sexual content via social media. Organized retail crime costs the American economy billions of dollars each year. This growing problem impacts families who see the cost of their groceries and every day needs go up to compensate for retail loss. We also see job opportunities lost as companies adjust to protect their bottom lines.
