Hotel Information:

The Westin Seattle will host this meeting. It will begin at 8:30 a.m. on Monday, October 11th and end on Tuesday, October 12, 2021, at 3:00 p.m. CWAG has a block of rooms reserved at \$189.00 plus 15.7% tax per night and a \$2.00 Tourism fee. Please call hotel at 888-627-8513 by September 12, 2021, to secure a room at the discounted rate. Make sure you mention the conference code **CWAG** to get the discounted rate. When calling for reservations a deposit equal to one night's room and tax are required with a major credit card to guarantee the reservation. Please confirm your length of stay and departure date with the hotel upon check-in. After completing the hotel check-in, there will be a \$50.00 early departure fee if guest's check-out prior to their scheduled departure day. The cancellation policy is 72 hours prior to the date of check-in.

The **Westin Seattle** is located at 1900 5th Avenue Seattle, Washington 98101. The direct phone line is 206-728-1000.

Ground Transportation:

Attendees should fly into the Seattle Tacoma International Airport (TAC).

For transportation we suggest Uber, Lift, or local taxi service. Its 13.3 miles route so a one-way trip the cost is approximately \$30. The LINK (light rail) is also available. The West Lake stop is two blocks from the hotel. Please keep in mind that the hotel does not offer complimentary parking.

Driving Directions:

From Sea-Tac Airport, get on WA-518 E. from Airport Expressway. From WA-518 E., take the exit for I-5 N. and travel north on I-5 for 12.4 miles. Take the Seneca Street exit #165. The exit will be on the left. Turn right on 6th Avenue and proceed north for six blocks. Cross over Stewart Street. The hotel will be on the left.
