ITEM FOR BID:

The Project consists of all work to be performed as indicated in the Project Manual, Drawings, and any posted Addenda. The work is a new structure, approximately 14,250 gross square foot single story building which will provide Clallam County and City of Port Angeles with a co-located essential facility to conduct emergency operations and 911 dispatch (PenCom). This facility will be built on an undeveloped 3.88 acre parcel near the William R Fairchild International Airport. Parcel Number 063007129050.

Substantial Completion shall be achieved within four hundred and twenty nine (429) calendar days after the Owner's (Clallam County and City of Port Angeles) Notice to Proceed. Final Completion shall be achieved within forty-five (45) calendar days after Substantial Completion.

In order to perform public work, the successful bidder and subcontractors, prior to Contract award, shall hold or obtain such licenses and registrations as required by State Statutes and Codes, and Federal and local laws and regulations and a Clallam County business license.

BID SECURITY:

Certified check, bank cashier's check or bid bond congruent with the Bid Bond Security Form (Section 00 43 30) as identified in the "Instructions to Bidders" is required to be submitted with each proposal, in the amount equal to five percent (5%) of the total base bid plus additive alternate bids (if applicable). Make bid security payable to the Clallam County, furnish bond executed by a licensed bonding agency authorized to do business in the locality of the Project. No bid shall be considered unless accompanied by such bid security.
