Under state law, if taxes are unpaid after the due date, penalties and interest will be charged as follows:

- Interest is calculated on the tax amount and penalty at a rate of 10% per year

Both taxes, penalty, interest and advertising become collectable by DMV registration withholding, Virginia income tax refund withholding, wage garnishment, judicial sale of property, levy, distress or otherwise (sec 58.1-3919 Code of Virginia).

Tax is assessed on personal property owned on January 1 of the tax year. Greene County is NOT a prorating locality. If the property was owned on January 1 of the tax year, then tax is due for the entire calendar year. Conversely, you are not taxed on personal property that you purchased during that current calendar tax year.

* Be owned by an individual or leased by an individual under a contract requiring the individual to pay the personal property tax; AND

* Be used for nonbusiness purposes.

The tax on the first \$20,000 of value on qualifying vehicles has been reduced by XX% this year. These reductions are based on local tax rates in effect on August 1, 1997. Exemption based on \$4.45 tax base.
