**Behavioral health care** to support children with emotional or behavioral disorders.

**Family safety and crisis services** designed to strengthen families and prevent child removal due to abuse or neglect.

**Refugee and immigrant services** to provide critical resources like English classes, economic development programs, and family support for our newest neighbors.

**Residential treatment for Iowa children and teens** with 24-7 trauma-centered mental health care.

**Early childhood services** for parents of young children, including home visits, classes, support groups, and parenting education.

**Mental health services** for children, adults, couples, and families in a compassionate, non-judgmental therapeutic environment.

**Foster care and adoption services** to recruit, license, and support foster and adoptive families in western Iowa.

**Services for people with disabilities**, ranging from 24-hour care to occasional respite care or Host Homes independent living for lowans with high intellectual or developmental disabilities.

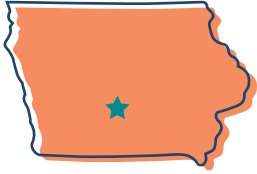

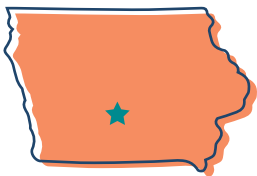

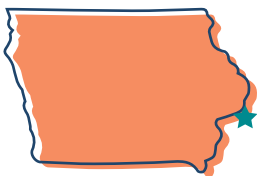
