Child Care Aware of NH powered by Southern New Hampshire Services is proud to offer the 4th Annual Training and Technical Assistance Institute. This year, Early Childhood and Afterschool Trainers, Technical Assistance Specialists, Consultants and others serving in a mentorship role, will gather to obtain an in-depth look at coaching using the Environment Rating Scale (ERS) Tools. As you know, Child Care Aware of NH in partnership with UNH and the Bureau of Child Development and Head Start Collaboration, has been offering various Environment Rating Scale training opportunities throughout the State through the Preschool Development Grant. Join us to partake in our efforts to spread how these tools can be used within your work and how it supports continuous quality improvement (CQI).

This training is designed to provide an overview of the Environment Rating Scales (ERS). In the morning session, the training will focus on the different Environment Rating Scales. Participants will discover how to use these tools for program self-assessment and continuous quality improvement.

In the afternoon, participants will examine coaching strategies and learn ways to promote continuous quality improvement of programs using the ERS Tools. The book, *Coaching with ECERS: Strategies and Tools to Improve Quality in Pre-K & K* will be used as a reference tool in this session.



Trainer Bio: Jaime Calcagni has a BA in Early Childhood Education. She is an anchor for the Early Childhood Environment Rating Scale-3 (ECERS-3). Jaime is the former facilitator of NH'S Quality Recognition and Improvement System (QRIS) Task Force. She served as a Technical Assistance Specialist in RI and worked directly with programs to improve the quality of their programs based on the ERS tools.
