Criteria for Programs:

Programs must be willing to:

- Review and sign a Memorandum of Agreement
- Review program's current practices to identify areas for growth and develop an action plan.
- Review action plan with staff and initiate steps to implement your program's plan.
- Work hand in hand with your assigned Training and TA Specialist(s) to work towards completing your program's goals.

Application Due Date: Friday, October 16, 2020

Selection & Notification Process: The in-house selection process will be based on program needs. Programs will be selected and notified by October 23, 2020. This round of Early Childhood Virtual TA Cohorts runs from November 2020 to June 2021. All participating programs will be listed in the November Monthly Minutes.
