Agricultural Land Preservation

Agriculture is an important industry and land use in Cumberland County and Pennsylvania. There are over 1,400 farms in Cumberland County and agriculture represents about 45% of the County landscape. Statewide, Cumberland County ranks #8 in total value of agriculture products, at approximately \$200M in crops and livestock products. The County is a leader in the dairy and cattle industries, ranking #5 in cattle and #7 in milk production statewide.

Agriculture preservation is an important investment in our economy, our environment and the overall quality of life. Preservation of Cumberland County's best working farmland benefits the agricultural community by securing the land base that is required to sustain agricultural operations and produce food and fibers. In today's market place, large clusters of farmland are needed to create a long-term business environment for farm operations.

The workshop is designed to provide an overview of the various planning tools a municipality can utilize to conserve important agricultural areas. Additionally, the course will cover county, municipal and non-profit farmland preservation programs as well as other services and education strategies that promote and preserve the agriculture industry.
