Grant Applications

What has NOT changed:

APPLICATION QUESTIONS

- These should look familiar! There have been some minor changes in application questions that are intended to make applications more efficient, clearer in intent, or better fitting for small/volunteer-only organizations.

Grant Applications

What has NOT changed:

ACTIVE GRANTS LIMITATION

- Maximum of one active grant per organization for Program and Organization Support grants (as eligible for each).

Grant Applications

What has NOT changed:

MAXIMUM REQUEST AMOUNT

- For organizations with operating budgets greater than \$125,000, the maximum request amount is \$25,000 per year.
- Organizations with operating budgets less than \$125,000 may request an amount up to 20% of their operating budget per request.
- Organizations that are primarily volunteer-driven and/or have a very small operating budget should contact the program officer to discuss the eligible amount for their specific situation.

What HAS changed:

RAPID RESPONSE UPDATES

- Guidelines for applying have been adjusted slightly, including additional categories under Emerging Opportunities to better fit requests that have been received over time.

Grant Applications

What HAS changed:

SHORTENED APPLICATION FOR SMALLER REQUESTS

- An abbreviated application will be available for non-governmental organizations with budgets under \$125,000 who are applying for a grant of \$5,000 or less in Program Support or Organization Support. If awarded, this would count as an active grant in the corresponding program.

Grant Applications

What HAS changed:

MORE TWO-YEAR OPTIONS

- Organization Support grants will now be offered for up to two years for both capacity-building and general operating support subtypes, with Program Support continuing to offer up to two years of funding.
 - For capacity-building, a two-year request should reflect a two-year timeline and budget (one for each year). This is the same as required for two-year Program Support requests.
 - For general operating support, organizations can indicate in the application if they would like to be considered for a second year of funding.
- Brief interim reports will be required for all two-year grants awarded prior to second year payment being issued.

Search by Organization Employer Identification Number (EIN)

Every organization has its own unique federal employer identification number (EIN), which it obtains by applying to the IRS. An EIN is typically a nine-digit number, shown like 12-3456789. A few charities have EINs with eight or fewer digits (normally shown with a leading zero like 01-2345678).

- Multiple organizations may submit a joint application for a collaborative project – contact Program Officer to discuss this further.
- Organizations based outside of Linn County may only apply for the Linn County portion of program costs.
