## *A message from Prevent Child Abuse NC*

In the fall of 2019, members of the Research and Policy Workgroup (a subcommittee of the [NC Collaborative for Children, Youth and Families](#)) began planning a series of events to be held in the fall of 2020 leading up to the election. The original plan had been to host day-long in-person institutes in different regions across North Carolina, but as planning continued into the spring of 2020, it became evident that the format would need to be virtual due to the COVID-19 pandemic.

Partners from a range of disciplines joined the effort to plan what would become the 2020 Regional Policy Institutes, including the [NC Collaborative for Children, Youth, and Families](#), [Prevent Child Abuse NC](#), [i2i Center for Integrative Health](#), [NC Child](#), [MomsRising](#), and the [Foster Family Alliance of NC](#).

Four Regional Policy Institutes were held in September and October 2020, drawing more than 600 participants statewide. The format was simple – a **welcome from Governor Roy Cooper**, an opening keynote, an Advocacy 101 presentation, a parent/youth voice keynote, and a legislative panel discussion. Each institute was 2.5 hours long with different speakers and presenters, and free for anyone to attend. Social workers, healthcare providers, advocates, parents and more all came together to learn from experts, champions, leaders and policymakers.

The following report represents a snapshot of the responses shared in the surveys that followed each institute. Feedback has been incredibly positive, and the NC Collaborative for Children, Youth and Families is looking forward to bringing more institutes to advocates across the state in the future.

### Virtual Format

Multiple respondents appreciated the virtual format. One said, *“I likely would not have been able to attend had it not been virtual [even] if there wasn't a pandemic.”*
