Denied 1. **5966 N. Santa Monica – Mike Steggeman** - The proposed project is to review tabled plans for a façade change by adding lime stones to the exterior walls, replacing the front building lights to LED lighting and replacing existing windows with new vinyl windows.

Approved 2. **4975 N. Woodruff – Jonathon Newby** – The proposed project is to demolish the existing one-story family room at the rear of the house and to construct a new two-story addition on the existing foundation of the demolished family room.

Approved 3. **5400 N. Lake Dr. – Mark Sollazo** – The proposed project is to construct a new two-car garage addition to the North side of the home and to remodel the rear addition.
