On June 1-3, CSG West convened the inaugural Border Legislative Academy (BLA), the first of its kind professional development program for legislators of the U.S.-Mexico border region. The 2017 BLA class was comprised of twelve legislators representing the U.S. and Mexican border states of California, Arizona, New Mexico, Baja California, Sonora, Chihuahua and Nuevo Leon.

Hosted at the University of California San Diego's Center for U.S.-Mexican Studies (USMEX), the BLA provided a mix of professional development and informational sessions geared to afford practical skills and accelerate the knowledge of participating lawmakers about the U.S.-Mexico border region. Sessions addressed the current state of the U.S.-Mexico relationship, highlighted legislative institutions and available public policy resources, and provided an overview of key cross-border institutions and the complexities of governing along the border.



Participating lawmakers were also exposed to communication strategies and approaches to building a culture of excellence in legislative institutions, and learned of success stories from stakeholders in the frontlines of fostering greater binational cooperation. CSG West chair, Washington Senator Sam Hunt, presided over the program.

CSG West, along with USMEX, secured topnotch speakers to serve as BLA faculty. This included U.S. and Mexican officials in the areas of diplomacy, academia, think tanks, transportation, security, philanthropy and trade. Faculty partners included the University of California San Diego, the U.S. Consulate in Tijuana, the Mexican Consulate in San Diego, the Universidad Autonoma de Baja California, the San Diego Association of Governments, Colegio de la Frontera Norte, the Conference of Western Attorneys General, the Wilson Center, the U.S.-Mexico Border Philanthropy Partnership, the Border Trade Alliance, Texas A&M International University, the San Diego Regional Chamber of Commerce, Congressman Scott Peters, Bill Graham Communications and the Robert D. Billie Ray Center at Drake University.

The BLA is supported through a grant from CSG's 21st Century Foundation, which served as seed funding for the program.
