CANCELLATIONS: Cancellations must be submitted via email to info@iltgolf.com. Verbal or phone cancellations cannot be accepted. • 90+ Days Before Departure: a \$100 per person cancellation fee applies to all confirmed passengers. Waitlist status for upgraded seats/rooms does not negate this fee. • 89-30 Days Prior: Cancellation fee is 50% of the total tour cost. If the final payment is not received by the due date, the booking will be canceled and the full deposit forfeited. Within 30 Days: 100% of the tour cost is non-refundable.
