Thank you for your interest in serving on the Board of Directors for the South Metro Denver Chamber. This form will be reviewed by the Chamber's Nominating Committee when creating a slate of candidates to fill vacancies for Board of Director positions. For the Nominating Committee to attain the best slate of candidates we do ask that you please complete the following application in full. This does not guarantee your nomination, but if chosen, we want to offer you a rewarding opportunity and make the most of your special talents and expertise for the benefit of the entire Chamber.

**Chamber Mission:** The South Metro Denver Chamber provides value to its member and the community through being action oriented in business transformation, economic development and public policy, providing members the opportunity for community involvement and a platform to build strategic partnerships and remarkable relationships.

**Terms of Service:** A minimum of a 1-year term (beginning September 1, 2021); Directors may serve no more than a total of seven (7) consecutive years, which shall be comprised of a combination of one (1), two (2) and/or three (3) year terms. Upon completion of a total of seven (7) years, Directors shall be required to resign from the Board and shall not be eligible for re-election to the Board until one (1) year has elapsed.

### **Position Description:**

- Has solid ethics, a strong community involvement and belief in the purpose of South Metro Denver Chamber
- Attendance at monthly board meetings (currently held the fourth Thursday of each month from 7:30 am – 9:00 am)
- Has demonstrated the ability to serve through committee service or other community involvement
- Has time to commit to the Chamber, its activities, various Chamber events and its Board of Directors as needed – attendance at two or more Chamber events per month.
- Understands the board members may not act where there is real or perceived conflict of interest
- Are eligible to serve 1-3 years

The following guidelines are used by the Nominating Committee in preparing a slate of candidates to fill vacancies for the Board of Director positions:

- Activity and involvement with South Metro Denver Chamber
- Current member of South Metro Denver Chamber, in good standing
- Skills, knowledge, experience and education related to the Chamber, its activities, its programs, board responsibilities to business as a whole

- Primary consideration will be individuals and their potential contribution versus consideration of a single organization
