Golf Cart Permit

Requirements & Limitations

- Unless grandfathered in before 2021, the licensee(s) must provide proof of a state issued persons with disabilities parking plate or placard. If placard, ownership by the licensee must be provided.
- The licensee(s) site must have adequate parking space to accommodate their golf cart
- The golf cart must be electric powered. No gas-powered golf carts are permitted. Only one golf cart permitted per site.
- The licensee must provide proof of current liability insurance to operate their golf cart on Fish Lake Beach park property.
- Licensee(s) and adult drivers of their golf cart must be over 21, must have a valid drivers' license to drive the golf cart.
- The licensee(s) must pay the seasonal Golf Cart permit fee: \$50.00
- The licensee(s) and their adult drivers of their golf cart must abide must by the Golf Cart usage rules.

Golf Cart Rules

1. The licensee must be driving or be riding as a passenger on the golf cart for it to be used on Fish Lake Beach property.
2. Each passenger on the golf cart must have a seat. The number of passengers must not exceed seats. Children 3 years and younger may sit on an adult passengers lap. Children may not sit on driver's lap and drive golf cart.
3. Golf Cart Permit must be affixed to exterior of the golf cart in a visible position. If windshield is present, it must be on windshield. All old permits must be removed. Only the current 2021 is to be displayed.
4. The site number of licensee(s) must be on the back and both sides of cart not less than 4" size.
5. Golf carts must be operated in a safe manner at all times. Reckless driving, horseplay, off-roading, or any other misuse of the golf cart will not be tolerated.
6. Alcohol use is not permitted on golf carts. Anyone suspected of driving under the influence of alcohol while driving a golf cart will have the permit revoked immediately.
7. Passengers must stay seated at all times.
8. Licensees and their adult drivers must follow posted speed limits. Speed limit within park is **10 MPH**.
9. Licensees and their adult drivers must yield to pedestrians.
10. Licensees and their adult drivers may only drive on main roads. Driving across grassy areas, the beach, through septic fields, or through campsites is prohibited.
11. Golf cart must have mounted front and back lights and must be used after sunset.
12. Golf cart may not be driven between midnight – 6am.
13. Golf cart must be secured when not in use. Do not leave key in golf cart when not in use.
14. All manufactures' safety devices must be in/on the golf cart and in good condition. Golf cart must be maintained on the interior and exterior.
15. Golf cart may not be used to tow or pull.
16. Management reserves the right to restrict access to any areas due to weather or FLB activities. Golf cart drivers are expected to honor roadblocks and flagged areas unless otherwise directed by staff.
17. Licensees assume all responsibility of their golf cart and its use. Fish Lake Beach, its officers and employees are not liable for any injury, damage or loss, however caused, to any person or real property on Fish Lake Beach property.
18. Fish Lake Beach reserves the right to change these guidelines at any time and reserves the right to apply these rules at its sole discretion. Changes will be published in the newsletter and the Seasonal Facebook page. Licensee(s) are responsible to check these sources regularly to be aware of new or updated policies regarding golf cart usage.

Rule Violations

The safety of everyone at Fish Lake Beach is paramount therefore any violation of the rules above will be enforced for the safety of all. When violations are witnessed by Fish Lake Beach owners or employees Fish Lake Beach will respond as follows:

- **First violation: A verbal warning along with a copy of the detailed incident report will be emailed to the licensee and kept on file.**
- **Second violation: A \$50 fine will be assessed and due immediately. A copy of the detailed incident report will be emailed to the licensee and kept on file.**
- **Third violation of a rule(s): Permit to operate a golf cart on FLB property revoked.**

The licensee(s) agree to comply with the Golf Cart Rules and accept the terms and conditions of the Golf Cart Permit.
