PROJECT DESCRIPTION

The Florida Department of Transportation (FDOT) is making roadway improvements to West Eau Gallie Boulevard (State Road 518) from Jones Road to the Sarno Road/Trent House Drive intersection in Melbourne.

There are two projects associated with these improvements. The focus of project number 439778-1 is to widen and resurface West Eau Gallie Boulevard to add an additional eastbound through lane from east of I-95 to the intersection of Sarno Road/Trent House Drive. Project number 439779-1 involves improvements to the I-95 interchange ramps, including extending the right-turn lane from eastbound West Eau Gallie Boulevard to the southbound I-95 on ramp and adding a second left-turn lane from westbound West Eau Gallie Boulevard to the southbound I-95 on ramp.

In addition, crews will make drainage improvements, install concrete curb and gutter systems and resurface the roadway from the I-95 access ramps through the Sarno Road/Trent House Drive intersection. Eastbound and westbound bicycle lanes will be added within the project limits. At the west end of the project, sidewalks will be constructed on the north and south sides of the roadway.

WHAT TO EXPECT

Motorists should expect single lane closures on West Eau Gallie Boulevard from 8 p.m. to 6 a.m. on weekdays. There will also be temporary daytime and nighttime single lane closures on the weekends. Work on the I-95 access ramps will require short-term, nighttime lane closures and detours for construction activities.

Electronic message boards and other signage will help direct traffic through detours and lane shifts. Motorists are asked to use extra caution while driving through the work zone. The contractor will maintain pedestrian access to sidewalks during construction using signed detours, and/or temporary walkways and ramps, when appropriate.

Please be advised it is the property owner's responsibility to remove or relocate any privately owned irrigation, landscaping, decorations, and/or fencing within the FDOT right of way before the start of construction. The FDOT reserves the right to cut and cap any irrigation and remove any items that conflict with the planned work in the right of way. Additionally, the level of work activity will vary during different phases of construction, and paving operations will be intermittent. Please note the construction schedule may change due to weather or other unexpected conditions.
