PROXY FOR VOTE ON CONGREGATIONAL SLATE

Section 3.8 of Adat Shalom's Bylaws provides that you may vote by proxy if you are unable to attend the congregational meeting. You may grant your proxy holder either the right to vote as s/he sees fit (General Proxy), or you may grant your proxy holder only specific rights to vote as designated in your proxy instructions (Specific Proxy), **but not both**. Be sure to designate as your proxy holder someone who will attend the annual meeting.\* Also be sure to sign your proxy. Each adult member in good standing may submit one proxy. For this reason, in case you have two adults in your household, two blank proxies are provided for the vote on the congregational slate.

To be counted, your signed proxy must be received in the Adat Shalom office no later than Wednesday, May 15, 2019 or be personally given to the Secretary (Judy Ackerman) prior to the beginning of the meeting on May 16, 2019.

\* If you wish, you may designate Adat Shalom Board Secretary Judy Ackerman to serve as your proxy holder.
