PURPOSE:

- The purpose of the Parent Advisory Committee (PAC) is to review, advise, monitor and comment on the Pasadena Unified School District's Local Control Funding Formula (LCFF) spending and the draft and final Local Control Accountability Plan (LCAP) toward the achievement of all students.

ABOUT LCFF AND LCAP:

- Enacted in 2013, LCFF replaced the previous K–12 finance system and provides funding based on average daily attendance and supplemental funding for targeted disadvantaged students. (pupils classified as English learners, those who meet income requirements to receive a free or reduced-price meal (FRPM), foster youth, or any combination of these factors (unduplicated count).

TERMS:

- Members serve three-year, staggered terms. Terms begin July 1, 2017

TIME COMMITMENT

- Three to four public meetings of 2 hours in length and additional preparation time for meetings as needed. It is anticipated that there will be 6 – 7 two-hour meetings of the PAC each year.

NUMBER OF COMMITTEE APPOINTMENTS

- Six

- Parent/legal guardian of a child currently enrolled in a PUSD school; who are not in a conflict of interest position, (i.e., individuals, agents of employees or vendors who may stand to gain financially from a recommendation of the committee.
