Minutes

The Eighteenth Annual Session of the Eastern Regional Conference, Churches of God, General Conference met on Monday, April 16, 2018, at Doubling Gap Center, Newville, PA.

Pastor Tom Myers, Conference President, called the Conference-in-Session to order at 9:00 AM, opening with prayer. The theme for this year's Conference is "Empowering Life-Giving Ministries"

Roll Call: There were 267 pastors and delegates registered for Conference for the morning session.

Steve Long welcomed everyone to Doubling Gap Center and gave instructions regarding lodging, meals and other items of information.

ON MOTION APPROVED the requests of various pastors for excused absences from Conference-in-Session.

ON MOTION ACCEPTED the Secretary's roster as adjusted as the official record.

ON MOTION APPROVED using the honor system with unassigned seating designating the voting area.

Parliamentarians appointed were Dr. Steve Dunn and Dr. Mike Walker.

Mr. Chris Clugh led a Song Service and Pastors Tom Myers and James W. Moss, Jr. led an Ordinance Service.

Military chaplains, Captain Ted Hamm and Major Scott King introduced themselves and invited everyone to talk with them about their ministry and check out their display table in the lobby.

ON MOTION ADOPTED the minutes of the Seventeenth Annual Conference Session of the Eastern Regional Conference, the minutes of the January 2018 Special Session of Conference, and the minutes of the Administrative Council since the Seventeenth Annual Conference Session.

ON MOTION APPROVED lifting from the Administrative Council minutes for separate action the ordination recommendations and the constitution proposal.

ON MOTION ADOPTED the business schedule with the privilege of the chair to adjust as needed.

Dr. Steve Dunn presented and reviewed the new constitution. He introduced the members of the Constitution Committee. Discussion and voting will take place on Tuesday.

Pastor Chuck Frank introduced the guest speaker, Mr. David Nelms from the Timothy Initiative. Dr. David Nelms is Founder and President of the Timothy Initiative. He is a former senior pastor and grew three different churches in Maryland, Iowa, and Florida. He received a Master of Arts degree from Moody Bible Institute, a Master of Divinity from Luther Rice University and His Doctor of Ministry from Luther Rice University. David is married to his wife Loretta and has three grown children and five grandchildren. He spoke to the Conference about making discipleship a priority and training those who are willing. He answered four questions: 1) What is the Great Commission? 2) What is a disciple? 3) What is a church? and 4) What is success? His challenge was to make disciple-makers by focusing on the Holy Spirit rather than programs, services, books or curriculum.

Conference was dismissed for lunch following announcements. Pastor Darrell Schrade offered prayer for lunch.

Mr. Chris Clugh began the afternoon session with a Song Service and Pastor Larry Longenecker led devotions.

Roll Call: There were 260 pastors and delegates registered for Conference for the afternoon session.

Commission on Multiplication: Pastor Chuck Frank showed several videos promoting the work of the Commission through multiplication of disciples. Their report is on pages 66-69 of the docket. He thanked everyone for their support of church planters. Pastor Dwight Lefever introduced the pastors who are church planters.

Commission on Pastoral Health: Pastor Dale Miller reported on the work and purpose of the Commission. ON MOTION RECEIVED the reports of Winebrenner Seminary, the Commission on Multiplication, the Commission on Pastoral Health and the Commission on Church Vocations.

A time of recognition was held for retirees. Those honored were John Good; Dennis Hall; Dennis Hamsher; R. Bruce Henneman; Robert Malick, Jr.; Jon Neely and Charles Riley.

Celebration of God's Servants: Linda Rosenberry presented the obituary report and recognized members of the committee. **ON MOTION ACCEPTED** with appreciation the Celebration of God's Servants report.

After announcements, Pastor John Cook offered prayer and Conference was adjourned until Tuesday morning, April 17, 2018.

A service was held on Monday evening featuring Pastor Greg Hench and the Revolution Crew from the Carlisle First Church of God. An ice cream social followed the program.

The Eighteenth Annual Session of the Eastern Regional Conference, Churches of God, General Conference continued Tuesday, April 17, 2018, at Doubling Gap Center, Newville, PA. with Mr. Chris Clugh leading in song and Pastor Jory Tobias leading devotions.

ROLL CALL: There were 272 registered pastors and delegates for the Tuesday morning session.

Four Breakout Sessions were available: 1) Having a Kingdom Mindset presented by Pastor Lance Finley; 2) What is a Healthy Life-Giving Church presented by Pastor David S. Williams; 3) Panel Discussion -- Living Externally as a Church presented by Pastors Zach Wilt, Charlie Zahora and Victor Glover; and 4) Prayer Focused Ministry – Stronger Together presented by Mrs. Diana Thomas.

Pastor Tom Myers, Conference President, called Conference-in-Session to order at 10:00 AM.

Financial Reports/Endowment Committee/2018 Budget: Colleen Gross, Finance Manager reported on the financial reports, referring to pages 71-79 in the docket. She referred to the 2018 budget and encouraged anyone with questions to contact her. Colleen shared a video on “Feed My Starving Children” and Pastor George Spangler of Turning Point Church of God, thanked all churches who helped in this project and encouraged more churches to become involved next year. Colleen recognized the many churches who are doing things in their communities such as having block parties and providing community meals. Frank Arva, Financial Secretary, talked about the finances of the ERC. His written report is on page 67 in the docket. ON MOTION APPROVED under Article VII – Commissions, Section 2, changing the name the Pastoral Health Commission to the Pastoral Family Health Commission.

ON MOTON APPROVED the new constitution as amended.

Pastor Jim Moss Jr., acting Executive Director, updated the Conference on the search for a new Executive Director.

Four Breakout Sessions were available: 1) Development of the Pastor presented by Pastor Wayne Good; 2) Discussion on the Physical Health of the Pastor presented by Kara Shifler; 3) Leadership Pipeline presented by Brandon Kelly; and 4) Facing the Fear: Preaching Generosity presented by Colleen Gross.

REVIEW OF MINUTES

The minutes of the Eighteenth Annual Session of the Eastern Regional Conference, Churches of God, General Conference, which met April 16-18, 2018, were reviewed and **ON MOTION, APPROVED** as circulated.

The minutes for Meeting No. 3, April 18, 2018, were reviewed and **ON MOTION, APPROVED** as corrected.

CORRESPONDENCE

We received a letter of resignation from Pastor Richard Bair from the Six Mile Church dated April 1, 2018.

PRIORITY BUSINESS

Home Mission Council Update – Jim Brandt updated the Council regarding the health of Home Mission Council. All is well. Interest rates have not changed recently. About 212 certificates have been issued. Nineteen loans are outstanding.

The Council keeps a 15% reserve. He shared about the connection between Scotland Campus and the Home Mission Council. It has been determined after much consideration that the Home Mission Council's past loans to Scotland Campus are legitimate, but no new loans will be granted to Scotland Campus. Home Mission Council is behind what is happening at Scotland Campus.

Review of 2018 Annual Conference Sessions and Comments – Most of the comments were positive.

Update on Executive Director Search – Eight candidates have been reduced to three. Further Interviews of these three will take place in the early part of August.

STAFF AND FINANCIAL REPORTS

J. W. Moss, Jr. – J. W. Moss, Jr. said he can give one day a week to his work as Interim Executive Director.

D. S. Williams – D. S. Williams reported on the status of the commissions on which he serves.

C. P. Frank –Antoine Lassiter shared about his experience with the Exponential Multipliers Learning Communities. These communities help individuals unpack practical principles and apply them in their

own context. Those in the community also help one another. It has been life-changing for Antoine and has enhanced his vision. C. P. Frank asked for \$10,000.00 to fund six persons to be part of these cohorts which meet three times each year. The Commission on Multiplication will pick up the remaining expenses. **ON MOTION, APPROVED** granting \$10,000.00 for this request to the Commission on Multiplication. The money will come from the Administrative Council Discretionary Fund.

Finance Manager: C. S. Gross shared that finances are healthy right now in the ERC. Income is up, and expenses are down. Colleen visited Conference Sessions for some other denominations to see how they do things. ERC giving is about \$11,000 above budget, year to date. Fund Balances are over \$100,000.00. All commission budgets need to be submitted by September 4th.

ON MOTION, APPROVED funding Colleen Gross to do teaching in Kenya at a cost of \$2000.00 to be taken from the Administrative Council Discretionary Fund.

Financial Secretary: H. F. Arva reported that we are about \$11,000 above budget to date. We are 1.39% above last year's giving to date.

ON MOTION, RECEIVED the written and verbal reports of the staff.

Commission Reports

Church Health – 15 Healthy Church Checkups have been conducted. Pam Kaylor has resigned, and Sam Williams will resign next year from the leadership of Bible Quizzing. **ON MOTION, APPROVED** Barb Maurice to serve as a member of Commission on Church Health. Church Health is seeking training venues for local churches. Church Health is working on developing ConNEXTion Groups in the conference. The commission is wrestling with how to do training with bi-vocational pastors.

Credentialing & Placement – **ON MOTION, APPROVED** the Commission's credentialing policy, retroactive to June 14, 2018 as follows:

The Eastern Regional Conference of the Churches of God, General Conference recognizes four credentials for ministry.

1. Lifetime Ordination
2. License
3. Transitional License
4. Provisional License

LIFETIME ORDINATION

Lifetime Ordination is the standard credential for ministry in the Churches of God, General Conference. It signifies that the ordained person is fully qualified and authorized to perform all pastoral duties and offices. It is valid for the lifetime of the ordained person unless surrendered or recalled following due process by the conference/eldership in which ordination is currently held.

Every person ordained by the Eastern Regional Conference must:

- a. Have been a member of a local congregation of the Churches of God, General Conference for at least three years immediately prior to ordination.
- b. Have completed an approved course of academic preparation including but not limited to an undergraduate degree in Bible or ministry, an M.Div Program, PTI or MTI.
- c. Have completed a course on the history and polity of the Churches of God, General Conference and an approved course on homiletics. An exception to the homiletics requirement may be granted if the Commission on Credentialing and Placement recognizes a candidate's previous preaching experience as meeting this need.
- d. Have completed at least one year of licensed ministry experience in a local congregation of the Churches of God, General Conference or a ministry approved by the Commission on Credentialing and Placement.

- e. Have been recommended for ordination by the Commission on Credentialing and Placement.
- f. Have passed the required steps as outlined to them by the Commission on Credentialing and Placement which may include but is not limited to a written and oral theological examination.

LICENSE

License is the preliminary credential for ministry granted to most ministers (exceptions would include those receiving a Transitional or Provisional License as outlined below). It signifies that the licensed person is fully qualified and authorized to perform all pastoral duties and offices, though their education may be incomplete. It is the expectation that all those candidates who receive a license and remain active with the Churches of God, General Conference will continue their study with the motivation of receiving Lifetime Ordination. A license is valid for a maximum of five years and may be renewed on an annual basis upon expiration. It becomes valid upon ministerial placement in a local congregation of the Eastern Regional Conference or an approved parachurch ministry.

All persons licensed by the Eastern Regional Conference must:

- a. Be a member of a local congregation of the Churches of God, General Conference.
- b. Have completed at least forty percent of their education as outlined above.
- c. Have completed an approved course on homiletics. An exception to this requirement may be granted if the Commission on Credentialing and Placement recognizes a candidate's previous preaching experience as meeting this need.
- d. Have completed appropriate background checks and a Pastoral Readiness Inventory or similarly demonstrated personal readiness of pastoral ministry.
- e. Have passed the required steps as outlined to them by the Commission on Credentialing and Placement which may include but is not limited to an oral theological examination.

TRANSITIONAL LICENSE

Transitional License is the preliminary credential for ministry in the Churches of God, General Conference, granted to those candidates who are ordained by another denomination or church and wish to serve under that ordination. It signifies that the licensed person is fully qualified and authorized to perform all pastoral duties and offices, and that the Commission of Credentialing and Placement recognizes their ordination as coming from a valid ministry partner. It is the expectation that all those candidates who receive a transitional license and remain active with the Churches of God, General Conference will seek Lifetime Ordination with the Churches of God, General Conference. Should such a goal be reached it will be required of the candidate to surrender their former ordination as the Churches of God, General Conference does not recognize dual ordination. A transitional license is valid for a maximum of five years and may be renewed on an annual basis upon expiration. Should a candidate wish to remain serving with the Churches of God, General Conference under their former ordination for a period longer than five years, they will be evaluated on a case by case basis and exceptions may be allowed. A transitional license becomes valid upon ministerial placement in a local congregation of the Eastern Regional Conference or an approved parachurch ministry.

All persons granted a Transitional License by the Eastern Regional Conference must:

- a. Be able to produce proof of Ordination with another church or denomination.
- b. Be a member of a local congregation of the Churches of God, General Conference.
- c. Have completed at least forty percent of their education as outlined above.
- d. Have completed an approved course on homiletics. An exception to this requirement may be granted if the Commission on Credentialing and Placement recognizes a candidate's previous preaching experience as meeting this need.
- e. Have completed appropriate background checks and a Pastoral Readiness Inventory or similarly demonstrated personal readiness of pastoral ministry.

f. Have passed the required steps as outlined to them by the Commission on Credentialing and Placement which may include but is not limited to an oral theological examination.

PROVISIONAL LICENSE

Provisional License is the preliminary credential for ministry in the Churches of God, General Conference, granted to those candidates who are authorized to minister either in specific locations or under specific provisions (including but not limited to oversight/mentoring assigned by the Commission on Credentialing and Placement). This credential is granted to those who either because of calling or qualifications/ability are licensed for specific ministry within the Churches of God, General Conference but are not necessarily licensed to perform all pastoral duties and offices. Those candidates who receive a provisional license may seek a license or lifetime ordination as appropriate. A provisional license is valid as long as the provisions as stated when the license is conferred remain in effect. Should these provisions change the candidate must meet with the Commission of Credentialing and Placement to reevaluate the status of their license. A provisional license becomes valid upon ministerial placement in a local congregation of the Eastern Regional Conference or an approved parachurch ministry.

All persons granted a Provisional License by the Eastern Regional Conference must:

- a. Be a member of a local congregation of the Churches of God, General Conference.
- b. Have completed at least forty percent of their education as outlined above.
- c. Have completed an approved course on homiletics. An exception to this requirement may be granted if the Commission on Credentialing and Placement recognizes a candidate's previous preaching experience as meeting this need, or if it is recognized that a candidate's provisional ministry will not include pulpit ministry.
- d. Have completed appropriate background checks and a Pastoral Readiness Inventory or similarly demonstrated personal readiness of pastoral ministry.
- e. Have passed the required steps as outlined to them by the Commission on Credentialing and Placement which may include but is not limited to an oral theological examination.

Ministry Training Institute Steering Committee – Steve Dunn updated the status of Ministry Training Institute. Sixteen students are registered for Churches of God History and Polity class at the Newville First Church of God. Classes have been planned and instructors secured for the fall semester which begins September 4th. MTI has secured \$2,150 in donations. Potential donors will be visited in about three weeks. Dennis Koontz is heading up this process and the goal is to raise at least \$15,000 for the remainder of 2018. MTI has developed curriculum offerings with course descriptions yet to be written. The pastoral track includes 13 required courses, plus mentored ministry and three electives. MTI has also developed proposed curriculum offerings for the Ministry Enrichment Track. Courses cost \$150 per cost or \$100 to audit. Thanks to the pastors and elders at Grand Point Church, MTI will have a physical office to replace the current virtual office. A website has been set up and can be found at www.ercministrytraining.com. Tammie Gitt is the webmaster. The Facebook page ERC MINISTRY TRAINING INSTITUTE has reached over 1000 persons. **ON MOTION, APPROVED** the board of directors and job descriptions of MTI. **ON MOTION, APPROVED** Don Snyder as the liaison from the Administrative Council to MTI.

C. P. Frank – C. P. Frank reviewed the last ten years of church planting in the ERC. We have had 55 planting projects in the last ten years with 29 of them still active in the ERC today. These 29 have a present active attendance of 1572 persons. Church plants have returned \$275,000 in tithes.

Finance Manager: C. S. Gross shared that spending is below budget. We have received \$144,000 more than we have spent thus far in 2018. The financial secretaries of the commissions have the details of each commission's spending.

Financial Secretary: H. F. Arva reported that giving has declined the last two months compared to budget. As of the end of September, giving is slightly below budget for the year. Giving to date is \$9500 more in 2018 than 2017.

Youth ministry total attendance was the second highest ever. Over 400 youth made a spiritual response. 81 ERC churches had at least one summer camper. That is 35-year low. The percentage of Church of God youth at camp is trending down. 419 volunteers participated in 2018. Our

volunteer participation helps make Camp YoliJwa as successful as it is. There were 208 different rental groups in 2018. Many college groups come to DGC. The girls' dorm restroom project was completed. Project are planned to replace the ceiling lights in the gym and to install a treatment system for drinking water. Another project is rebuilding the lake's spillway which will cost about \$80,000.00. Donations of \$170,000 from individuals were received in 2018. A plan is being developed to build a meeting house on the other side of the road. The lake will need dredged before we build a meeting house.

On March 2nd, I got to hold my first grandson, Lewis Arnold Williams. For thirty-one years, I have been proud of my children; now I get to enjoy the second part of parenting. Just as I have appreciated watching my children grow and the almost daily photo updates of my grandson, I also appreciate and get excited about the spiritual growth of those I disciple and mentor. My journey of being discipled by someone other than my parents began when I was a teen participating in Bible Quizzing. Donna Sturr, my coach, may not have used those terms, but that is what she and her husband, Phil, were doing. I took that model and continued it for twenty-four years of coaching my own quiz teams. This discipling process has taken other forms over the years as I've worked with various adults. Today, I still enjoy discipling individuals, but more joy is derived from the spiritual grandchildren I have. I do not receive daily photos of them; I don't even know their names. That doesn't matter. What matters is the gospel is being shared with people in ways I don't even fully grasp, and I praise God for a pastor and wife who invested in a quiet timid teen because that is what God called them to do. Who are you investing in so the gospel message multiplies? A healthy, life-giving church equips people so they are more like Jesus.

I personally spend a lot of my time discipling people one-on-one because Jesus devoted much of His time that way. He also spent time with larger groups, so I find myself working with commissions and local churches. I serve on the Church Health and the Credentialing and Placement Commissions. Each of these provide me with multiply ways of getting into the local congregations to work with their leadership teams. For Credentialing and Placement, I along with placement representatives, have helped 16 congregations in their search for a new pastor. For Church Health I've worked with various people on the healthy church checkups and helped resolve various conflicts and conducted council retreats. I've participated in 43 church meetings, met with 36 pastors and preached in 22 congregations since last year's conference sessions. We are working together to foster healthy life-giving missional communities.

Much has been accomplished this year to move the strategic plan forward. But the work is far from complete. Three points of emphasis for developing leaders and congregations to move the plan forward during this coming year are. First, we will move to improve our understanding of bi-vocational ministry. It must be seen as a viable and meaningful means of ministry, and in some cases, it is more practical and beneficial for the congregation and the pastor than to push for a full-time pastor. Secondly, we will strive to do more research into the distinctions of rural ministry over suburban or urban. All three setting are valuable, and we have churches in all three realms. But most of the books written deal with urban and suburban ministry, while little current work has been done for rural ministry, which still makes up 77 of our 147 current congregations. Thirdly, we need to invest in our new pastors. Some form of gathering and training time will be established for those who join our fellowship, whether they are entering their first ministry or are joining us as seasoned pastors. These are the opportunities we will be focusing our attention on this year so we can effectively accomplish the mission of developing healthy life-giving ministries.

God has richly blessed the ERC in the last 11 years since He commissioned the 2020 Initiative in 2008. God far exceeded our man-made goals of 20 churches by 2020! In addition to our Multiplication Commission Report (in the docket) that gives a great picture of how God has been multiplying disciple-makers, everyday missionaries, new ministries, and new churches, here's a further glimpse of how God has been working in the ERC's multiplying vision since 2008!

- An average of 1636 new people are attending our new ERC churches each week!
- More than 10% of our Conference worshippers are now worshiping in new/young ERC Churches!
- God's blessed us with 58 new church projects in less than 10 years, done with different methodologies to multiply disciples, including churches giving birth: for example, Grand Point Church gave birth to a campus. <https://vimeo.com/groups/2020initiative/videos/291633099>
- On any given week, (compared to 2010), there are 28 new ERC churches available to worship in
- Our new churches since 2010 have given back in tithes to the Lord and the ERC more than \$280,000!
- God is transforming lives with more than 500 salvations and 260 baptisms!
- And as we move into a discipleship multiplying culture, already more than 70 people at 9 ERC churches are involved in discipleship training and disciple-making:

Also, you can see the entire picture by reading Our 2019 Multiplication Commission Report, which gives church project updates, glimpses into the 2019 Strategic Plan, and updates the progress of more than two dozen of our churches and how they are beginning to have a vision for multiplying disciples, everyday missionaries, ministries, and new churches.

- In the last year almost 200 people in the ERC, representing more than 40 churches, have attended some of our multiplication training sessions and conferences!
- These training sessions have been led by nationally-recognized instructors:
 - David Nelms, Bill Couchenour, Dan Brindley, Exponential, Ralph Moore, etc.

We believe more and more people are hearing God's call in the ERC to be SENT out and empowered by the Holy Spirit to evangelize, become disciple-makers, initiate new ministries, and plant new churches. And the result of sending out our local church missionaries is that miracle stories are abounding! For example:

- A church building in Halifax, is given away for \$5 to start a new missional community (Uplift Community COG), which in turn displays generosity in feeding and clothing folks in Harrisburg!
- Thousands of meals are being served to the homeless in Thomasville, NC, (Orchard Church)!
- Battered women and women with felonies are being restored to faith in Daytona Beach (Salt & Light)!
- Through Victor Glover's Last Days Ministry, 100's of inmates in several states are experiencing God's tremendous "Fathers on the Move" power for their life!
- More than 130, 00 meals are prepared for Feed My Starving Children by Turning Point Church (Mechanicsburg)!
- And on and on God keeps using ordinary broken people to help rescue people from a Christ-less eternity!

Another year of seeing God work – or as my friend Victor Glover says – “Work Jesus!” And yet the multiplication of disciple-makers, everyday missionaries, ministries, and new churches has just begun to help our churches see that we’re to be senders, not seaters; and Christ-followers, not consumers!

Report of the Financial Secretary



Our theme for the 2019 Eastern Regional Conference is “Connected” and is taken from Acts 2:42 where the early church, *“devoted themselves to the apostles’ teaching and to fellowship, to the breaking of bread and to prayer”*. All of these united the church under the headship of Jesus. As important as these activities are they do not comprise everything that the first century church engaged in. Act 2:44 and 45 tells us that *“all the believers were together and had everything in common. Selling their possessions and goods, they gave to anyone as he had need”*. It is apparent that they understood stewardship and generosity. They gave from what God had given to them.

CHURCH HEALTH COMMISSION 2019

The purpose of the Church Health Commission is to oversee the advancement and development of healthy churches within the Conference. This involves but is not limited to overseeing and enhancing the relationships between the pastors, the congregations and the conference by resourcing churches, pastors and leaders in the best practices for ministry and healthy life-giving church operations and to oversee all property issues, and to intercede internally when necessary.

Our Commission members focus on the health of the church. We desire to equip each congregation with methods of building healthy life-giving communities. We seek to empower pastors through mutual relationship via ConNEXTion groups. We are seeking best practices for ministry in today's world and providing various training opportunities. Because the Bible teaches there is one church, we give oversight and insight to congregations when they seek to purchase, build, sell or take on loans. As we learn from other congregations and the broader context of churches, we are able to share best practices.

We endeavor to develop and maintain constructive relations within each church, to enhance the effectiveness of ministry by both the pastor and the congregation. We help bear the burden of pastoral change as it relates to the health of the church. We address all church conflict issues by prayer, love and counsel for both the pastor and the congregation. Congregations and pastors are encouraged to use our Commission as a counselor to resolve conflicts within the church body. Although we seek resolution through mutual agreement, the final decision in regard to internal issues or conflict management is the responsibility of the Commission. As we care for each other and bear each other's burdens, we show the love of Christ. Thus the whole body of Christ grows more and better disciples. Ephesians 4:3-4 says, "Be completely humble and gentle; be patient, bearing with one another in love. Make every effort to keep the unity

of the Spirit through the bond of peace. There is one body and one Spirit, just as you were called."

What does a healthy church look like? In doing our work, we operate from the understanding that a healthy life-giving church is built upon the foundation of Jesus as Lord. It is protected from all that is wrong by understanding Scripture is our only rule of faith and practice, and it must be applied with grace and truth. The Holy Spirit brings us together as a body. Our response to the work of the Holy Spirit is worship and prayer. The congregation must equip people to be like Christ, reach its community and world for Christ, care for people as Christ did, and develop systems so that all of these parts function together for the work of God's kingdom.

There are other areas of responsibility for our Commission as defined by the Eastern Conference Constitution which are outlined in our developing operations manual. We do not minimize their importance, and we address them when necessary as we continue to plan and develop those areas of responsibility. We plan on having the operations manual approved and available in the near future. In the meantime, we are aggressively expanding our efforts to accomplish our Commissions goal of visiting all churches in the Conference within three years. Making initial connections with each church is important. We believe that, as a result of these on-site visits, the Conference will better understand the needs of the church and how we can best help each church become a healthy life-giving missional community. We believe that this direct line of communication will foster a better relationship, understanding, and a desire to serve the Lord together. Solomon wrote, "Plans fail for lack of counsel, but with many advisers they succeed" (Proverbs 15:22). Our hope is that, in working together, we can help God's plan for each Eastern Regional Conference church be realized to His honor and glory.

In the past year we have helped pastors and congregations build healthy life-giving missional communities by:

- overseeing nine ConNEXTion groups,
- conducting twenty-seven healthy church checkups,
- having 13 pastors attend a Turnaround Pastors Boot Camp,
- sending 3 people to the Rural Matters Institute sponsored by the Billy Graham Center.

We also recognize a need to raise up next generation leaders within the church. To this end, Bible Quizzing is being conducted at eight churches who have twenty teams with a total of 70 youth participating. Nine more young adults participated in this year's PULSE retreat for those considering ministry and how to live life on mission.

Our desire is for all Eastern Regional Conference congregations to be healthy life-giving communities. If there is any way we can help, please contact us.

CREDENTIALING AND PLACEMENT

In the new structure of the ERC, the Commission on Credentialing and Placement replaces the former Commission on Church Vocations and the Commission on Church and Pastor. During this first year of our existence we have invested a lot of time in updating our guidelines and policies that will guide our work in our various responsibilities. We are updating and creating a new manual of operations.

The big idea behind combining the two commissions is very simple at heart. It is believed that as a region we can do better identifying, equipping and matching those who have been called with the people who will best be served by them. We have broken down what we do into its component parts – the calling and equipping followed by the testing and transition.

The Calling and Equipping

Part of the work of the Vocations Commission has always been to discern and, hopefully affirm, the calling in individuals who come to us. This is step one. We like to get to know the person and hear about his or her conversion and calling. We like to experience the heart of the person ourselves and also hear about the people in his or her life who have affirmed the anointing.

If there is a sense that we are to move forward (and most often there is) then we begin to assess the individual's particular situation and what level of education and training will be necessary in order for the person to be tested for credentials. As you know, people can come to us from a variety of different milieus:

- The person could be “fresh out of the pew,” so to speak, and exploring their sense of calling for the first time with us. This person, depending on their current level of education may be recommended for a Master’s level program or the Pastoral training Institute (soon, hopefully, to be the ERC’s own MTI, Ministerial training Institute) In either case, we will provide the necessary information and, particularly if the person is being “sponsored” by a church, we will provide the person with the Pastoral Readiness Inventory – to be completed and returned for evaluation. From that point, we will not see or formally interview the person again until they have completed 40% of their chosen educational program. (They would be eligible for licensing at that point)
- The person could come to us from a different tradition or denomination. These folks usually have credentialing from the previous body and, after exploring his or her calling, anointing, and the reasons why they want to join the C.O.G.G.C., we will explore how that credential was achieved and what educational and practical experience the individual has. In this initial interview we also explore theological and doctrinal compatibility with the CGGC i.e., we explore not only the primary theological premises upon which our Christian faith is based i.e.. The Trinitarian view of God, substitutionary atonement; but doctrine of the Church of God that must be affirmed – the role of women in ministry, his or her concept of the security of the believer, and the Ordinance of Feet Washing. Once it has been established that it is proper to move forward, we help create a plan for the person based on their level of education and experience. Depending upon circumstances, we may also ask for the completion of the PRI.

- The issuance of a precursory theological “examination” – a written document through which the local church as well as the Credentialing and Placement Commission could determine a candidate’s basic theological leanings would serve quite well as the initial step to take with someone entering our denomination from a different tradition.

At the current time the educational offerings that we have are the Master’s level or DMin programs provided by Winebrenner, or the Pastoral Training Institute, also administered by the seminary. The advent of the MTI, instituted as a result of the foresight of several persons in the ERC, is also able to provide the necessary education and training through its own educational arm.

The individual may need just “History and Polity,” (if we recognize their credentials from another tradition), a full educational program (if starting from scratch), or something in-between. The rules for those who have embarked upon an educational program through us (DMin, Master’s, PTI) and wish to seek credentialing as soon as possible are that the person have completed at least 40% of his or her program along with the requisite “History and Polity of the Churches of God”, as well as a homiletics course.

Testing and Transition

When an individual becomes eligible for credentialing, it follows that he or she will be tested. This testing takes two forms – written and oral. Generally speaking, and you will see the nuances of these generalities below, we will give a basic theological examination to any individual who is seeking credentialing with the ERC before even proceeding in order to make certain we and they are theologically compatible.

When licensing is the question, we have altered the process to include both a written and oral examination. A candidate is given three weeks to complete the written portion and then is scheduled for their time in front of the commission. Pastoral Licenses have been reduced to only two: Provisional and Non-Provisional. Non-Provisional licenses are activated upon assignment and are valid for 5 years before further review.

The ordination process is very similar. If a candidate meets the prerequisite experience and education, he or she is provided with a written examination to complete within three weeks and returned to the commission. This accomplished, the candidate will be invited to defend his or her written exam as well as be examined on other questions orally in front of the commission. The ordination exam also now includes a “Biblical Literacy” portion. This is a written portion designed to reflect the candidate’s level of biblical acumen.

So what happens next? This is the piece of what we are trying to do that has the potential to make the greatest impact. As it stands, we have a rather convoluted approach to matching qualified candidates with open positions. This is a result of many things, only some of which we can fully address given the nature of our denomination’s polity, but there are certain aspects of the process that we can certainly make better.

If we could imagine a flow chart of sorts – on the left is the candidate and on the right is the best possible placement for that candidate. How can this person move through the processes of credentialing and placement in order to make that best match? That is the question that we are addressing as a commission. Here are some of the issues that we face and are seeking to resolve:

- A candidate is recruited from outside the denomination, the local congregation desires to hire them (and in some cases does) then presents him or her to the commission for “approval.” This places the commission in the awkward position of being a “rubber stamp.” In the cases which it is deemed that the candidate is not theologically compatible and is not eligible for credentialing in the ERC it also causes hard feelings between the conference and the local church.

- We would like to institute what may be called a precursory theological examination, that is, a short, written exam that touches upon basic Christian theology and Church of God doctrine. Doing this before an individual from outside the denomination is asked to candidate for a position could mitigate the problematic situation of bringing a theologically or doctrinally incompatible person before the commission for credentialing.
- An ERC credentialed candidate is not even introduced to a congregation in need due to a misunderstanding, miscommunication or some other obstacle that stands between the left side and the right side of the flow chart.
- A congregation (right side of the flow chart) is in need of a new pastor but finds that there is not a consistent, well-defined approach via the ERC that would serve them to find the pastor. The congregation becomes frustrated and/or acts simply out of ignorance and hires, or seeks to hire, an unqualified candidate.

So we see that the issues can originate from either side of the equation. It is part of the purpose of the Commission on Credentialing and Placement to eliminate these issues by creating, promoting and consistently adhering to a better-defined methodology of introducing qualified candidates to congregations in need. How, exactly, will this be accomplished? That is part of our tasking – as we work to figure out the path, create it, and implement it, we are thinking in new ways about old problems and have engaged in a great deal of open and frank communication.

Communication on all fronts is ultimately what will lead us on a smoother, more positive and productive path from one side of the flow chart to the other. To this end, we would like to establish best practices and better protocols to follow as we work to connect pastors and congregations – this is the transition piece – and we must ask ourselves, “What can we do better to facilitate the connection of called, equipped and tested pastors, teachers and leaders with the perfect congregation?”

In order to complete the transition into a pastorate, and intentionally follow-up in order to ensure a proper fit and healthy situation, the “placement” part of this commission is tasked with not only developing, but instituting and vigilantly monitoring the following aspects of our work:

- Track all pastors and maintain an in-house list of all pastors working through the “flow chart.”
- Establish, promote and support a consistent protocol for churches to follow when seeking a pastor.
- Over time, develop best practices that will serve the local church in identifying and supporting people from their own pews who are being called into leadership positions, including vocational ministry.
 - This is part of the “tracking” that was mentioned above. We should develop definite steps that both candidates and churches take in order to “make the path straight,” so to speak, and eliminate the breakdowns in communication that we are currently experiencing.
- Serve local congregations as the “bridge” between pastors which will include not only helping join pastor and church, but following up with support.
 - This will also include training, placing and supporting intentional interim pastors.
 - This will also include members of our team willingly visiting churches in need to help them with the process and/or troubleshoot any issues with the process.

A year ago the ERC Ministry Training Institute (MTI) was created. In this first year God has been at work in extraordinary ways as God has done immeasurably more than we could have asked for or imagined. We had 16 students when we offered our first class last July. As the summer semester begins in two weeks we will have grown to more than 70 persons involved in the program in one of our three tracks.

A Board of Directors was elected by the Ad Council and Dr. Steve Dunn was hired part-time to set up the MTI program from the ground up. The Grand Point Church in Chambersburg provided an office. The Board is composed of Ed Rosenberry, chair; Michael Walker, vice chair; Judd Spencer, secretary. The other members are: Tammie Gitt, Dennis Koontz, Barb Lichtenberger Maurice, Don Snyder, Kim Shifler, and Rodger Scheuing.

The MTI is divided into three tracks: Pastoral Track which focuses on preparing persons for credentialed ministry; Ministry Enrichment, courses designed to strengthen the biblical knowledge and ministry skills of lay persons; and Continuing Education, courses from both the Pastoral and Ministry Enrichment Tracks that allow pastors to sharpen their professional ministry.

We operate three 12-week semesters with three hours of class each week. Fall and Spring we offer four courses in five sections and in the summer, 3-4 classes in weekend intensives. Including this upcoming semester we will have offered the following classes: Churches of God History and Polity, Old Testament I and II, The Theology and Practice of Christian Worship, Gospel of John, The Teaching Ministry of the Church, Discipleship and Spiritual Formation, Ministry to Children, Youth and Their Families, The Churches of God and Contemporary Social Issues, History of Christianity, Biblical Theology. All of our classes are taught at the Master's level.

We have assembled an excellent faculty, all of whom are involved in practical ministry in their areas of expertise. Each has a master's degree or a doctorate. They are: Dr. Kimberly Shifler, Dr. Steve Dunn, Dr. Michael Walker, Anthony Zumbo, Brian Warner, Judd Spencer, Lewis Button, Ed Rosenberry, Nathan Buck and Diane Hakes.

Because of our major commitment to strengthening the Northwest District we have named Jeff Musser as the District Director for the Northwest District.

Not having a campus to support, we have been blessed by local churches providing classrooms: Martinsburg, Newville, Mount Holly Springs, Carlisle, Churchtown, Mt. Pleasant and Grand Point have been those churches.

Although we had no fixed budget the first year, our operating expenses for the 7 ½ months of 2018 were roughly \$37,000. We held a successful find-raising effort at the end of 2018. Our goal was \$10,000 but we raised over \$19,000. Because of this and a \$15,000 subsidy from the Conference, we finished in the black about \$14,000 including some prepaid tuitions for 2019. Our budget for 2019 is \$81,000 which includes a second subsidy from the ERC for \$15,000. We are seeking to raise \$50,000 in 2019. Our goal is to be self-supporting thorough contributions from churches, ministry groups and churches sometime in 2020.

In 2019 we are adding more classes, the Director is moving from 25 hours to 35 hours per week and we have hired a very part-time administrative assistant, Sheila Divelbiss. Sheila will be overseeing the growing student records and accounts. In 2019 we hope to find enough regular support to operate a classroom center in the Lancaster area just we have now developed in the Carlisle-Mechanicsburg corridor, Martinsburg, and Chambersburg.

Plans for the 2019-2020 academic year include the following classes: New Testament I and II, Pastoral Care and Counseling, Homiletics, Ministry to Men, Ministry to Women, Leadership in the Church (a course for lay leaders), Systematic Theology, Psalms and Wisdom Literature, Religion in America, Spiritual Formation (a course for lay persons).

Because of the advance standing of students transferring in from the PTI at Winebrenner, who also are taking more than one course per semester, we will have our first graduation on Saturday, December 7, 2019 at the Grand Point Church in Chambersburg.

ERC: More than 70 people in the ERC are using a couple of our recommended disciple-making tools!

Salt and Light: Pam Jordan launched church on the beach in Ormond Beach, Florida on April 7. She already leads a disciples making disciples group called PUSH and has plans for more outreach also.

Mt. Pleasant: Zack Wilt is sending out Christina Grey and a team to begin a new church in Adams County.

Turning Point: George Spangler led a recently completed second year project of Feed My Starving Children with over 132,408 meals prepared by many churches.

Think Kingdom Kannapolis: Antoine Lassiter relaunched/rebranded on Easter and is in the multiplying process in Atlanta and Austin.

Exponential Church: Gilbert Thurston is multiplying through the disciple-making strategy of both one-on-one and small group Discovery Bible Study. More than 30 people are attending.

Last Days: Victor Glover has 2 churches and working on 4 micro church locations, plus multiple Fathers on the Move in both Federal prisons along with state prisons in various states.

Orchard Church: Jimmy Grainger launched public worship in Thomasville, NC on Sunday, April 7.

New Dimensions: Everett Spencer is using our Discipleshift Tool (DT) and hopes to see 19 people learn to multiply as they develop as disciples.

Grace Fellowship: Reginald Byrden would like to plant 3 churches in the next 5 years, and we have talked about using our discipling tools.

Central Manor: Scott Davis has a desire to plant churches/campuses in Millersville, Columbia, and Maytown.

Acosta's (3): Are building up their training center in Columbia and looking for a new church to start in Lebanon.

Bridge of Hope: Larry Longenecker has a desire to have a multiplication movement, but they are focused on expanding their meeting space first. Their current rental space is to be purchased this year.

Chambersburg/Grand Point (2): Planted a campus in Shippensburg on 9/9. Lawrence Metzler has expressed a desire to help train other churches/leaders in the region on growth/reproducing and multiplication. The new campus is reaching more than 300 people a week.

Uplift Community: Looking towards Harrisburg for a new church planting in the future. April Ocasio is presently using our SCDT. She took several people to Exponential 2019 Orlando and is looking to begin a micro church ministry center.

Higher Hope: Mike Schooley sent out a team to plant the HUB in Elmira in 2018 and is looking at starting a multiplication network with the HUB. He has the next planter on staff to continue that vision.

The HUB: Jeremy Cranmer leads the HUB Church in Elmira, New York and is multiplying leaders and ministries.

New Providence: Dwight Lefever co-chairs our Multiplication Commission and the church has 26 persons using one-on-one discipleship to release disciple makers.

Home Faith Communities: Dennis Regitz started the first micro church in Washington Boro and now has a second one underway in E-town. It also has a vision for multiplication and is looking to network additional multiplying churches.

Friendship Community: Logan Ames is beginning the process of sending a leader to the Spring Grove, PA area, first as a small group and then seeing where God leads.

***ADDENDUM: It's training time in the ERC! God is moving in amazing ways in the ERC and the evidence is in how many people and churches are dedicating themselves to learning and living out God's new vision! And training is one of the key factors. For example:

- From the churches listed above, 9 ERC churches are learning and moving forward in some sort of multiplying vision.
- Also, last week 27 people from 10 ERC churches went through 4 days of multiplying ministry training at the Exponential Conference.
- And a week prior to that, 103 people representing 28 churches attended our 4th annual Evangelism Summit.
- Prior to that 7 pastors and churches received training at a micro church conference and 5 committed to being part of a pilot micro church ministry center team! Each one of them will start multiplying micro churches!
- 7 multiplication-minded pastors, representing 5 churches, are participating in several Exponential Co-hort groups that are bringing leaders from around the country to study and learn how to move to a multiplication culture in our local and regional churches.

God is at work in the ERC, and His people are following His call! These are just some of the churches and pastors exploring or dedicating themselves to disciple makers by which we hope to see the multiplying of leaders, everyday missionaries, ministries, and new churches for the future in the ERC!



2018 Report to the Eastern Regional Conference

The year 2018 was a time of organization for the Pastoral Family Health Commission. During the year, the Commission designated representatives who were tasked with providing regular contact with pastors in each district, wrote and submitted the Commission handbook to the ERC Administrative Council for approval, and established policies that have helped to guide how it cares for the Eastern Region's credentialed pastors and pastoral families.

More importantly than what its members did at each month's meeting is how the Pastoral Family Health Commission members represented the Eastern Regional Conference in reaching out to provide loving care to pastors and their families. From encouraging our retired pastors, spouses, and widows at the annual banquet, to sharing a meal with a pastor who needed a shoulder to lean on, the Pastoral Family Health Commission members invested their time and prayers to help active, retired, and unassigned pastors and their families be as healthy as possible with the Spirit's help.

The Commission also began to compile a list of free or low cost retreat centers where ministry couples can reconnect with each other and with the Lord. Through the Pastoral Family Health Commission, clergy couples may access a lengthy list of counseling services at low or no cost as well.

The Commission designed and promoted the regional Couples in Ministry Retreat, the fall Prayer Day, the ERC Prayer Retreat, and the district Pastor Appreciation banquets, hoping more of the Eastern Regional Conference's pastors would participate and develop deeper friendships with other ministry couples.

Because of the generosity of many of our Eastern Regional Conference churches, the Pastoral Family Health Commission was able to provide financial assistance to numerous pastors and pastoral families who needed food, health care, help with unforeseen medical bills, and other financial needs. It was the joy of the Commission members, serving as God's representatives and stewards of His resources, to personally meet with pastors and/or their spouses during those times when they were emotionally or financially exhausted. It is the prayer of the Pastoral Family Health Commission that each ERC pastor, pastoral spouse, staff person, retiree, widow or widower, and credentialed person without assignment will grow to trust the loving care provided by us who serve them and who boldly lift them before the Lord.
